  - delete Table 2 including its heading, and insert the following:

- delete "NSW Industrial Noise Policy. Appendix 5 sets out the meteorological conditions under which these criteria apply and the requirements for evaluating compliance with these criteria" and replace with "NSW Noise Policy for Industry"; and
- d. delete the Note and replace with the following:

#### Notes:

- Should an agreement with a landowner be terminated for any reason, the Applicant must comply with the noise criteria in Table 2.
- Receiver locations are shown in Appendix 5.

#### 7. In condition 7 of Schedule 3:

- a. in sub-condition (b), delete the words "meteorological conditions when the noise criteria in this
  consent do not apply (see Appendix 5)" and replace with "noise-enhancing meteorological
  conditions":
- b. in sub-condition (d) after the word "regular" insert the word "attended"; and
- c. in sub-condition (d) delete the words "in accordance with Appendix 5".

#### 8. In condition 8 of Schedule 3:

- a. in sub-condition (c), delete the words "meteorological conditions when the noise criteria in this
  consent do not apply (see Appendix 5)" and replace with "noise-enhancing meteorological
  conditions":
- b. at the end of dotpoint three to sub-condition (e), delete the full stop and replace with "; and"; and
- c. insert the following as sub-condition (f):
- (f) include a program to either:
  - attenuate the dump trucks prior to commencing quarrying operations in Stages 4 or 5; or
  - identify alternative mitigation measures and demonstrate that these measures will be implemented to achieve compliance with the noise criteria in this consent at all times.
- 9. In condition 11 of Schedule 3:
  - a. at the end of dotpoint three to sub-condition (e), delete the full stop and replace with "; and"; and
  - b. insert the following as sub-condition (f):
  - (f) include a program to implement the air quality emissions controls detailed in MR (Mod 3), including sealing the Quarry Access Road between Wisemans Ferry Road and the processing plant. Relevant controls must be implemented before:
    - any increase in extractive operations above 250,000 tonnes of product per year; and
    - the commencement of quarrying operations in Stages 4 or 5.
- 10. In condition 12 of Schedule 3, delete the words "that complies with the requirements in the *Approved Methods* for Sampling and Analysis of Air Pollutants in New South Wales guideline." and replace with the following:

that:

- (a) complies with the requirements in the Approved Methods for Sampling and Analysis of Air Pollutants in New South Wales (DEC, 2007); and
- (b) is capable of measuring meteorological conditions in accordance with the NSW Noise Policy for Industry (EPA, 2017),
- unless a suitable alternative is approved by the Planning Secretary following consultation with the EPA.
- 11. After condition 24 of Schedule 3, insert:
  - 24A. The Applicant must monitor trucks queuing within the right turn bay at the quarry intersection on Wisemans Ferry Road and, in the instance that there are trucks regularly queuing at the intersection, extend the length of the right turn bay to the satisfaction of TfNSW.
- 12. In condition 28 of Schedule 3:
  - a. in sub-condition (f), after the words "3.30 pm);" delete "and";
  - b. at the end of sub-condition (g), delete the full stop and replace with "; and"; and
  - c. insert the following as sub-condition (h):
  - (h) include a protocol to monitor truck queuing behaviour in the right turn bay at the quarry intersection on Wisemans Ferry Road, and trigger points for implementing the intersection upgrade required under condition 24A.
- 13. In condition 31 of Schedule 3, delete the words "Figure 2,".
- 14. In condition 32 of Schedule 3, delete the words "Figure 2,".





Figure 1 – Tertiary Sands and Friable Sandstone Extraction Areas









Figure 1 – Residential Receiver Locations
