KEY PROJECTS

I held the role of Environmental Manager, answering to the Project Director for The Northern Road Stage 3 Project in Penrith, Sydney. My team and I managed the approvals, compliance and construction of a significantly environmentally challenging project. Due to the operational motorway, a large portion of the works are being undertaken at night. This places additional management and regulation on construction activities for impacts such as noise and vibration as well as stakeholder management and community engagement.

I provided extensive input and review into tenders for Projects including Sydney Harbour Bridge Deck Upgrade (2019), Western Sydney Airport Bulk Earthworks and The Northern Road Stage 5. Professional inputs included the subjects of contamination, remediation, compliance and approvals, environmental system establishment and engagement of specialist services.

As the Environmental Manager for the North Western section, I lead a team of 5 in the early phases of approvals management, contamination assessment and early works for WestConnex 3A. Key tasks included obtaining approvals for early works and the pricing and establishment of subcontractors and consultants for contamination assessment, test drilling, geotechnical investigations and site establishment.

This linear road upgrade included the acquisition and modification of over 120 property parcels in order to facilitate the works. I worked in continuous communication and cooperation with the community liaison and property teams to provide advice and updates to all stakeholders including attending community information events, responses to complaints and enquiries and face to face communications as required. I also gained invaluable experience in the management of contamination and site remediation, achieving a site remediation solution that provided significant cost benefits for the client and contractor as well as best practice environmental outcomes. The Project involved the amalgamation of multiple environmental assessments and determined approvals into a single Project delivery team and as such, a complex compliance program. Project updates and modifications required the management of multiple addendum REF's and EPL variations during my time as the Environmental Manager.

My role was the Environmental Manger for the Newell Highway (Trewilga) Upgrade. The Project faced several key environmental challenges including widespread flooding in 2016 and significant design changes. The latter, required preparation of Addendum REF and assessments of significance for impacts to species listed under the EPBC Act (1999) and the TSC Act (1995), which I was able to complete in-house, along with modification to the Project EPL.

DPE approved alternate ER for the Nambucca Heads to Urunga Pacific Highway Upgrade Project. In this role, I provided independent environmental review of works, reporting and management plans, reporting directly to the Department of Planning & Environment and Roads and Maritime Services.
