Modification is sought to allow for. <ul style="list-style-type: none">• The importation of VENM and ENM, principally to backfill the extraction area and create a final landform which better integrates with the surrounding landforms.• On-site processing of selected, high sand content VENM and ENM.• An increase in the number of traffic movements permitted each day (from 100 to 140).• An extension to the period of approval from 2025 to 2030.• Removal of a condition limiting the area of exposed and active quarry extents.

How is the modification substantially the same as the original development?


On the basis that the additional development activity (VENM and ENM management) is ancillary and beneficial to the extractive industry development, does not require any significant intensification of operations and would be managed to limit impacts on the environment and surrounding landholders, it is concluded that the modified development will be substantially the same as the Quarry development and can be modified under section 4.55(2) of the EP&A Act.
