I am writing to you in regards to the above mentioned proposal with the Department of Planning, Industry and Environment, and too which I strongly oppose.

I am appalled at the fact that there has been no consideration for the residents health and safety. The traffic report in this proposal, stated an increase of between 300-800 vehicles per hour, and this will be operational 24/7. And the increase risk of road accidents with possible fatalities , with 2 driveways for 2 "industrial estates" side by side.

Also the lack of community participation, I only got a letter 2 weeks ago, informing me regarding this, and I only have to 25 November to respond ( which I have done ). The report mentioned that a community meeting was held in June/July with 28 registered participants but only 4 attended. I had not received any notification regarding this matter, in fact none of the residents I have spoken with, who will be greatly affected, had been notified. This precinct/ area has the extension of the Marrickville Metro Shopping Centre, the Metro line and is directly under the flight path. Our health will be affected, and the structural impact on our homes will be enormous. This proposal should not be allowed to go ahead, and I am hoping that you can consider, assisting in opposing this proposal, as the sitting member for Marrickville in the NSW parliament.

Also what compensation if any will the residents of Bourne St and Leicester St most affected, . be provided. I would also like Woolworths to disclose any political donations they ( CEO ,board and affiliates) have made, as I had to disclose in my submission to the Department ; [REDACTED]
