## Description of proposal

The project involves the continuation of the Dubbo Quarry operations, and includes:

- the continued extraction and processing at the existing quarry site at a rate of up to 500,000 tonnes per annum;
- extension of the quarry life by a further 25 years from the date of determination;
- development of two new extraction areas to the west and the south of the existing site and expansion of the internal road network;
- modification and expansion of existing water management infrastructure;
- an average of 100 truck movements per day and a maximum rate of up to 242 truck movements per day;
- extraction and processing activities at the quarry from 7 am to 6 pm Monday to Saturday; and
- progressive rehabilitation of the site.
