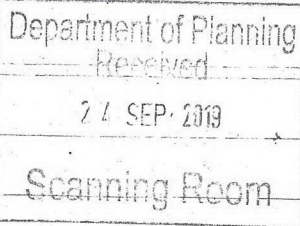

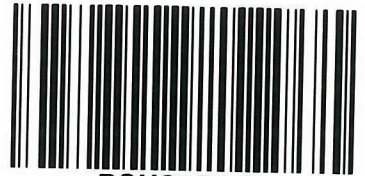

McPHILLAMYS GOLD PROJECT
SSD-9505 - OBJECTION

By way of background my wife and I conduct a small Murray Grey beef breeding entity at the above address, prime agricultural (A1) land in the district, lifestyle properties as ours valued at \$11,000/\$16,000 an acre.

We previously sold our large holding at Yolong/Wellington for the current property in a semi-retirement guise.

Karen and I object to the mine on the following basis:

- the likely affect to our groundwater-potable water critical to our operation by a high capacity bore (4kms away only),
- perceived economic affect on our property value due the knowledge of and visual affect to the pristine and attractive environment.
- The expected increased road traffic given that we are on the corner of Guyong and Victoria Rds, hence much higher usage and therefore noise levels. Vehicles from the north would travel Pretty Plains Rd, Guyong and Victoria Rds

to adjacent Blayney prior to turning left to Kings Plains on the Mid-Western Highway. There are also blasting implications.

• Concern re the saline water being piped from Mt Lyell - there are no figures yet available and we fear contamination of the soils/water table.

(tailings dams leak)

• Concern re the tailings dam being positioned over the Bellubula feed valley.

• concern over dust permeating our property and the area. Silica is a known contaminant and there is much press currently re Silicosis?

• Given the above the impossible situation that the current residents of Kings Plains are expected to reside in and endure - Kings Plains is a significant historical village and should be protected.

We have not provided any political donations.

I write this letter on a personal basis to register my objection to the above project on the basis of

- the effect on groundwater - we are just 4 kms away
 - the expected increase in road traffic as we are on corner Guyana Rd Vittoria Rd, the likely transit roads to the mine for Orange way
 - given our proximity the likelihood of dust & blasting affecting our pristine environment / lifestyle blocks are high value in this area
 - Concern re the tailing dam being situated over the Bellubula tributary
 - the proximity of the historical village of King Plains & its residents.
 - Concern as to the quality of the water being piped from Mt Lyell.
- I have not given any political donations in the last 2 years.
