Description of proposal

The proposal involves:

- Expanding the extraction area and continuing quarrying operations for a further ten years;
- Increasing the annual extraction limit from 455,000 tonnes to 750,000 tonnes;
- Clearing approximately 43 hectares of native vegetation;
- Upgrading and relocating existing on-site infrastructure;
- Constructing additional on-site infrastructure including a concrete batching plant, concrete recycling facility and asphalt production plant;
- Amending quarrying operating hours to 24 hours per day 7 days per week;
- Transporting quarry products to market via public roads; and
- Progressively rehabilitating the site.
