Roberts Road Data Centre (SSD-10330) Response to Submissions

ATTACHMENT 1 Department Comments

Relationship between SSD-10330 and 10 0142

1. Section 1.5.1 of the Environmental Impact Statement (the EIS) notes the proposed development and the existing data centre (approved under 10_0142) would form part of a combined facility operated by Canberra Data Centres Pty Ltd. It is subsequently requested the response to submissions (the RTS) clarify the relationship between 10_0142 and SSD-10330.

Consideration should also be given to surrendering the project approval 10_0142 and subsequent consolidation of the existing on-site data centre operations into any consent given to SSD-10330.

Potential noise impacts at Flavex Lane

2. Section 6.2.4 of the EIS describes a number of 'conceptual' mitigation measures which may be installed to ensure compliance with the project noise trigger levels (PNTL) at Flavex Lane.

The Noise Assessment predicts the night-time PNTL would be exceeded at Flavex Lane under temperature inversions. It is requested the RTS detail the specific mitigation measures which would be installed to ensure compliance with the PNTL. The effectiveness of these mitigation measures must be supported by additional noise modelling undertaken in accordance with the Noise Policy for Industry (EPA, 2017).

Landscaping

- 3. Given the comments provided by Blacktown City Council in its submission dated 31 January 2020, please update the landscape masterplan to replace:
 - (i) Pyrus calleryana 'Capital' trees with an alternative tree species (either native or exotic) which will provide a larger tree canopy along internal roadways to the north and south of the data centre building
 - (ii) Elaeocarpus grandis trees with an alternative tree species (either native or exotic) which is better suited to the local climate.

Consultation with the EPA

The Department recommends the Applicant consult with the Environment Protection Authority directly regarding the comments provided in its letter dated 22 January 2020, to ensure they are appropriately addressed as part of the RTS.
