INTRODUCTION

This report is in response to Palerang council's request, to obtain information on the concerns that there is a suspect grave site within the playing field block. O'Donnell Griffin conducted a survey designed to locate any such area using Ground Penetrating Radar technology in the area of concern which totalled approximately 80 square metres.

OBJECTIVE

The objective of this project is to confirm or discount the presence of ground conditions that could be connected to a grave site within the above mentioned location.

- A. If there is any indication that such areas exist, to identify their location(s).

SITE DETAILS

The area to be surveyed was an open sports field with a number of trees on the edges of the grounds.



OUTCOMES

After carrying out an inspection of the area to be scanned it was clear that the entire site would be able to be surveyed. scans were carried out and adjustments to the GPR were carried out as necessary. Several continuous lineal 2D scans were taken and one area was found to be an area of interest at the time of the survey. The area that did show the anomalies was marked on the ground using red marker paint and shown to the representative.

CONCLUSION

ODG using the ground penetrating radar has efficiently and effectively carried out a GPR survey as requested by Palerang council.

The area was surveyed / scanned using the SIR-3000 GSSI GPR for suspect grave site. one area of interest was found and marked with red survey paint.


