Description of proposal

The above state significant development (SSD) was exhibited from 17 June 2021 to 14 July 2021. The Applicant (Department of Education) has lodged a Response to Submissions and Amended Proposal. The amendments to the proposal include:

- kiss and ride facilities moved from Aprasia Avenue to Wilkins Way.
- provision of a single mid-block pedestrian crossing on Gorman Drive instead to two pedestrian crossings on Gorman Drive.
- conversion of the Special Education Learning Unit kiss-and-ride facility on Gorman Drive to two
 15-minute parking spots and two disabled parking spots.
- relocation of a digital pylon signage to the corner of Gorman Drive and McPhail Way.
- revisions to the landscape design and trees identified for removal to facilitate relocated kiss-and-ride.
- minor updates to layout and design, including façade materials for Block A and Block C.
