RESPONSE TO SUBMISSIONS – SSD-9249 MOD 6 SYDNEY FOOTBALL STADIUM – INCLUSION OF PRECINCT VILLAGE AND CARPARK ENVELOPE

We write on behalf of Venues NSW in response to your letter dated 30 November 2021, which requested a response to the submissions received during the public exhibition period for Modification 6 to State Significant Development Consent SSD-9249, relating to the Sydney Football Stadium Redevelopment Concept & Stage 1 Works.

This Submissions Report responds to the issues raised during the public exhibition period to satisfy the provisions of Section 4.39(e) of the *Environmental Planning and Assessment Act 1979* (EP&A Act) and Clause 85A of the *Environmental Planning and Assessment Regulation 2000* (EP&A Regulation). This letter should be read in conjunction with Modification Application and all supporting documentation dated 15 October 2021.

Further, this letter should also be read in conjunction with the response report prepared for the separate, concurrent modification to State Significant Development Consent SSD-9835, relating to the detailed design, construction, and operation of the Precinct Village and Car Park (SSD 9835 MOD 7). All physical works are encompassed in this Modification Application to the Stage 2 consent.

1.0 Introduction

1.1 Overview

Venues NSW lodged a Modification Application under Section 4.55(1A) of the EP&A Act with the NSW Department of Planning, Industry and Environment (DPIE) to modify State Significant Development (SSD) Consent 9249 relating to the Sydney Football Stadium Redevelopment Concept & Stage 1 Works, at 40-44 Driver Avenue, Moore Park.

The proposed modifications seek to amend the conditions of consent in support of a concurrent modification to Development Consent SSD 9835 for a new Precinct Village and Car Park (SSD 9835 MOD 7). This will include replacing the approved at-grade carpark (known as MP1) with a multi-level carpark and new public domain areas including tennis courts, flexible event spaces, a children's playground, and a single storey retail pavilion.

SSD 9249 MOD 6 was placed on public exhibition between 28 October 2021 and 24 November 2021. The submissions received during the exhibition of the Modification Application are addressed by this Submissions Report.

This response identifies and provides an assessment for each of the matters raised in the submissions received during the public exhibition period. It should be read in conjunction with the Modification Application and all supporting information dated 15 October 2021. This response has been prepared in accordance with Section 55 of the *Environmental Planning and Assessment Regulations 2000* (EP&A Regulations), as well as the *State Significant Development Guidelines Appendix C: Preparing a Submissions Report Guideline*.

1.2 Purpose of this Report

The purpose of this Submissions Report is to respond to the submissions received from both community and government stakeholders during the exhibition of the Modification Application. This Submissions Report has been prepared to satisfy the provisions of Section 4.39(e) of the EP&A Act and Clause 85A of the EP&A Regulation. Each of the submissions received have been collated, analysed and the relevant issues addressed. No changes are proposed to this Modification Application in accordance with Clause 55A of the EP&A Regulation.

1.3 Consultation activities prior to Public Exhibition

During the preparation of the Modification Application, a number of consultation activities with key stakeholders took place in order to create an open dialogue. These consultation activities are documented in the Section 4.55(1a) Modification Application prepared by Ethos Urban (dated 15 October 2021) and include consultation with agencies including the City of Sydney Council and Greater Sydney Parklands, the SFS Design Integrity Panel, and the Community Consultative Committee.

2.0 Analysis of Submissions

2.1 Overview

A total of fifteen (15) submissions were received in response to the public exhibition of the Modification Application, including submissions made by government authorities and agencies and the public, as set out in the following sections.

It is noted that several submissions were made jointly to SSD 9249 MOD 6 to the Concept Proposal SSDA and to SSD 9835 MOD 7 to the Stage 2 SSDA. Accordingly, while these submissions are identified in this Submissions Report they largely relate to the detailed design, construction and operation of the Precinct Village and Carpark and as such have been addressed in the separate, concurrent Submissions Report prepared for the modification to SSD-9835 MOD 7.

2.2 Government Agency Submissions

The following State government agencies provided a submission either jointly with MOD 7 to SSD-9835, or individually to this Modification Application, during the public exhibition period:

2.3 Public Submissions

A total of six (6) public submissions were received from individuals, landowners, organisations and special interest groups. This comprised five (5) submissions received from members of the general community and one (1) submission from the Paddington Society that was drafted to jointly consider this Modification Application with MOD 7 to SSD-9835.

3.0 Actions taken since Exhibition

While design development and refinement has occurred with respect to the detailed design of the Precinct Village and Carpark that is the subject of MOD 7 to SSD-9835, these changes have not impacted the scope of works proposed in this separate, concurrent Modification Application to the Concept Approval including the extent of the proposed envelope or the site boundary.

The actions that have been taken since exhibition to refine the proposed Precinct Village and Carpark are described separately in the Submissions Report prepared for MOD 7 to SSD-9835.

4.0 Response to Submissions

4.1 Response to Agency Submissions

DPIE's letter dated 30 November 2021 requested that a response be provided for the issues raised in those submissions made to the Modification Application.

Accordingly, this section provides an overview of the key issues that have been raised in each submission receive from government agencies. It is noted that as this Modification Application does not propose any physical works (including the construction and operation of the Precinct Village and Carpark), the majority of issues that have been raised in these submissions do not relate to this Modification Application and as such have been addressed instead in the separate, concurrent Submissions Report prepared for MOD 7 to SSD-9835.

The updated modelling confirms, however, even in this conservative scenario that intersections in the vicinity of the site retain an acceptable level of service with no change to current conditions. This verifies the conclusion drawn by TfNSW in their review of the proposal (refer to the MOD 7 submission as well) that the modification will have a negligible impact on the surrounding state road network and TfNSW infrastructure. • It is emphasised that no tree removal is proposed as part of this Modification Application. Notwithstanding this, as detailed in the addendum Arboricultural Impact Assessment at Appendix I of the MOD 7 Submissions Report, alternate options were considered during the post-lodgement design development process for tree retention. It confirms that one (1) tree previously proposed for removal can be retained, while replacement planting will be incorporated across the Precinct Village and Carpark in compliance with, and exceeding, the Concept Proposal and Stage 1 DA (SSD-9249) commitments

4.2 Response to Organisation and Public Submissions

This section provides a response to the key issues raised in each submission from organisations as well as the general public. Of these submissions, four (4) are objections, one (1) is in support, and one (1) provides comments.

The issues that have been raised in these submissions have been grouped into categories and addressed in the following table. It is noted that as this Modification Application does not propose any physical works (including the construction and operation of the Precinct Village and Carpark), the majority of issues that have been raised in these submissions do not relate to this Modification Application and as such have been addressed instead in the separate, concurrent Submissions Report prepared for MOD 7 to SSD-9835.

The edges of the carpark will be predominantly sleeved with other uses (including the existing ARDC building, the existing NRL building, and the approved stadium concourse) or will be screened by landscaping. • The proposed pavilion buildings provide a prominent backdrop and feature to the precinct. The scale is commensurate with their function as a gateway to the site and creates a deliberate transition from the stadium mass to the event plaza and village, while remaining empathetic to adjacent buildings, Driver Avenue and the neighbouring parklands. The tennis pavilion building is also approximately 4.5m high to provide a more intimate and human scale to what is a semi-private facility. • The masonry boxes above the pavilion roof are for exhaust. These boxes are designed as monolithic structures that are clad in brick to match the bricks used throughout the precinct village. The bricks have been chosen to visually soften and warm the built form, while celebrating the local contextual material used along Driver Avenue and throughout the sports and entertainment precinct. It is also proposed that the boxes would allow for native scrambling vegetation to grow up the walls to further reduce the visual impact and integrate them within the parkland setting. The boxes are also envisaged to be potential canvasses for artwork or commemorative installations.


5.0 Conclusion and Justification
