Description of proposal

The proposal involves the continuation of the existing Gunlake Quarry and includes:

- Extending the quarry life by 30 years;
- Extracting and processing of up to 4.2 million tonnes per annum of hard rock;
- Road transportation of quarry products to market;
- 24-hour quarry operations Monday to Saturday except between 6 pm Saturday and 2 am Monday;
- Direct employment of up to 228 full time equivalent personnel; and
- Progressive rehabilitation of disturbed areas and the life of quarry rehabilitation.

The State Significant Development (SSD) application, Environmental Impact Statement (EIS) and other accompanying documents will be exhibited from **Friday 8 October 2021** until **Thursday 4 November 2021** and are accessible electronically on the Department's website (www.planningportal.nsw.gov.au/major-projects/projects/on-exhibition).

At the time of publishing this advertisement, the Minister for Planning and Public Spaces has not directed that a public hearing should be held.
