### Description of proposal

Fit-out and adaptive re-use of two existing buildings (located within separate sites) for a new school (St Aloysius' College, Rozelle campus) to accommodate a maximum of 200 students (Years 7-10) comprising:

- demolition works, internal fit-outs, construction of a new lift and upgrades to the courtyard at 48 Victoria Road;
  and
- internal alterations to the existing building and allocation of four shared car parking spaces for staff at 2A-2B Gordon Street.
