Hello James,

I am sending these via email to start the attachments for the ICAG Inc. objection submission of proposed quarry seeking to destroy Deep Creek Limeburners Creek.

I ask please that the email from Colin Phillips (2019?) of the measurements from Hunter Quarries pit, to our place (11.4km), it was 9.9 to the end of our road and The Bucketts Way corner. We are another 1.5km up the road as you also know in person.

Please could I have this map resent to me and also put a copy with the ICAG Inc. submission as well. As this will be part of the (individual and Cumulative impacts) this quarry has on the environment and people's health and wellbeing, not to mention all those dirty water holding dams they have on their property that all overflow and run off-site making its way to Karuah River via numerous creeks. As you know we are impacted by all their dust, unless it rains, their blasting dust comes across from the ground up in clouds and hundreds of metres high in the sky. They have never dust supressed which causes runoff of course. All Departments continue to allow them to operate a noisy and dusty crusher without having it housed in the sound and dust reducing building like they had to do on their north pit when they were fined for exceeding dust and noise, yet they have done this for all this time on their south pit and the people suffer nose bleeds from the dust inside their homes. These people's houses shake from the ground up when the crusher is operating around 700 metres and more away and have contaminated their tank water, including ours at 11.4km away. You asked me if we could hear it, feel it, I advised thankfully we can't. Though our lichen died over 6 years ago now and our tank water went off around then as well. You also know that I suffered my first noise bleed in September 2019 when I left the window open a foot and forgot to get out of bed to close it with the lovely breeze coming in, I went off to sleep and did not get up to close window as we have to barricade ourselves in our house each night unless its raining as I said to you in previous conversations. We will all be 1300, 1500 metres more or less surrounded by almost 100 houses and hundreds of people to be impacted if DPIE or IPC approve this environmental catastrophy.

I have attached the Government map showing Deep Creek is a protected creek, this proposed quarry should not be allowed to continue and must be stopped.

I have attached a contour map of proposed Woodbury's quarry, they are impacting multiples of mountains (I had not realised this) and headwater creek systems of Deep Creek. At least 3 are showing on this map. As they have provided NO aerial photographs at all, then they should be refused on the grounds that their documentation is wrong, misleading, has information missing, or contradicts itself within the same page of their documentation, take blasting for example, it changes each sentence or point and they have written that they will blast each day.... what 365 days of the year?, then in other parts of their documentation it says they will not blast on Saturday, then they say they will blast Monday to Saturday, then they say 17 to 25 blasts a year, then they say 2 blasts a month actually equals 24 blasts not 25 as they have written.

The whole document is a sham mess and needs to be put in the bin and started again, or better still, refused outright, which is what we are all requesting DPIE and IPC to do.
