## Description of the development consent

Development of an asphalt batching facility to produce up to 150,000 tonnes of asphalt per year for the Newcastle and Port Stephens regions.

# Description of proposed modification

The modification involves increasing the approved annual production throughput limit of the asphalt batching facility from 150,000 to 250,000 tonnes per year. The anticipated increase in annual production throughput would be achieved by operating the existing facility more frequently. The size and hourly peak production rate of the facility would remain unchanged.

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning, Industry and Environment is exhibiting an application to modify the abovementioned approved State significant development (SSD).
