Description of the development consent

Development of an open cut coal mine, an underground coal mine and construction and operation of associated surface facilities.

Description of proposed modification

The proposed modification application involves:

- Allowing access for Ashton Coal Operations Pty Limited (ACOL) to extract a portion of the Ravensworth Underground Mine (RUM) coal reserves;
- Connection of the existing Ashton and Ravensworth underground workings;
- Receipt of ROM coal mined at RUM for processing at the Ashton CHPP;
- Extension of mining operations until approximately December 2035; and
- Other administrative changes to facilitate ACOL management and integration with the Ashton Coal Project.

Description of the development consent

Development of an underground mine to extract 7 million tonnes of coal per annum until 31 July 2024.

Description of proposed modification

The proposed modification application involves:

- Allowing access for Ashton Coal Operations Pty Limited (ACOL) to extract a portion of the Ravensworth Underground Mine (RUM) coal reserves;
- Connection of the existing Ashton and Ravensworth underground workings;
- Transfer of ROM coal from RUM to the Ashton CHPP;
- Minor changes to the configuration of the Pikes Gully and Middle Liddell Seam Longwalls;
- Extension of mining operations until 31 December 2032; and
- Other administrative changes to facilitate ACOL management and responsibility for a portion of the RUM consent area.
