## Description of the development consent

The expansion of an existing bulk liquid storage facility and development of associated infrastructure, comprising loading/unloading facilities, pipelines, safety systems, landscaping and fencing.

### Description of proposed modification

The proposed modification primarily seeks to install and operate a second thermal oxidiser and associated infrastructure. In addition, the proposed modification also seeks to remove an existing wastewater tank and repurpose an existing tank as a new waste tank.

The Department of Planning, Industry and Environment is exhibiting an application to modify the abovementioned approved State significant development (SSD).
