Description of the development consent

Tritton Copper Mine is an underground copper mine located approximately 45 kilometres northwest of Nyngan. The mine is approved to extract approximately 10.2 million tonnes of copper ore, import ore from other Tritton Mines, process ore on site and operate until December 2024.

Description of proposed modification

The proposed modification includes:

- underground mining of additional copper ore resource, referred to as the 'Budgerygar' deposit;
- installation of associated surface infrastructure;
- raising the existing Waste Rock Emplacement by approximately 10 metres;
- disposal of exploration drill cuttings and mill waste into the Tailings Storage Facility; and
- an extension of the mine life until December 2028.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment is exhibiting an application to modify the abovementioned approved development. The application and accompanying documents (including the Modification report) are on exhibition from **Wednesday 23 February 2022** until **Tuesday 8 March 2022**.
