#### Description of proposal

The application proposes to develop:

- an approximately 21 kilometre (km) bi-directional underground medium-pressure gas transmission pipeline from the existing Sydney to Newcastle pipeline to the Hunter Power Project (Kurri Kurri Power Station) near Kurri Kurri;
  - a compressor station;
  - an approximately 24 km underground high-pressure gas storage pipeline;
  - a delivery station to receive gas from the storage pipeline; and
  - other relevant ancillary infrastructure.

#### About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (Department) has received a critical State significant infrastructure (CSSI) application for the abovementioned proposal. The application, Environmental Impact Statement and accompanying documents are on exhibition from **Wednesday 13 April 2022** until **Tuesday 10 May 2022**.

At the time of publishing this advertisement, the Minister for Planning has not directed that a public hearing should be held.

The Commonwealth Minister for the Environment has decided that the proposed development, Kurri Kurri Lateral Pipeline Project, is a “controlled action” under the *Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)*.

This means that the proposed CSSI, in being assessed under Part 5 of the *Environmental Planning and Assessment Act 1979*, must also accord with the *Amending Agreement No. 1 to the Bilateral Agreement* under Section 45 of the EPBC Act relating to environmental assessment between the Commonwealth and the New South Wales Governments.
