Construction and operation of a DHL warehouse and distribution centre in the Gazcorp Industrial Estate with a total gross floor area of 31,860 square metres (m²). The proposal includes carparking, ancillary office space and landscaping.

Description of the development consent

The approved Concept Proposal involves the development of the Gazcorp Industrial Estate including 14 warehouse buildings, site levels, landscaping, infrastructure services and development controls. The approved Stage 1 development includes the construction and operation of a 45,225 m² warehouse and distribution building with ancillary office space on development Lot 10 and estate-wide bulk earthworks; site establishment works; construction of the internal road network; and extension of utilities and services.

Description of proposed modification

The modification application seeks to modify the approved Concept Plan to facilitate the SSD application by amalgamating Lots 11, 12 and parts of Lot 13 to create a new Lot 11; amending building height control applicable to Lot 11; and reducing the total gross floor area to facilitate the proposed DHL warehouse and distribution centre.

The Department of Planning and Environment (Department) has received a State significant development application and a modification application for the abovementioned projects.
