Description of the development consent

The Balranald Mineral Sands Mine is an approved mineral sands mine located within the Balranald local government area. The mine comprises two separate mineral sands deposits known as the West Balranald and Nepean deposits, which are located approximately 12 kilometres (km) and 66 km north-west of Balranald respectively. Open cut mining of these deposits has not yet commenced.

Description of proposed modification

Iluka Resources Limited is seeking a modification to the development consent to allow it to continue a bulk sampling trial to test underground mining methods at the West Balranald deposit for a further 6 years. The proposed modification also includes minor changes to the processing method and the layout of surface infrastructure (including the alignment of the northern section of West Balranald access road outside of the approved project footprint).

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (Department) has received an application to modify the abovementioned approved State significant development. The application and accompanying documents (including the Modification report) are on exhibition from **Thursday 26 May 2022** until **Wednesday 8 June 2022**.
