Description of proposal

Development of a new school (Minarah College) in five construction stages to cater for a maximum of 1580 students in Kindergarten to Year 12, including:

- demolition of existing dwellings and ancillary structures;
- tree removal and site earthworks;
- staged construction of a two-storey school building with separate built form wings incorporating:
 - an Early Learning Centre (ELC);
 - a School for Specific Purposes (SSP);
 - o multi-functional learning spaces for the primary and the secondary school;
 - o library, breakout spaces and school canteen;
 - o separate primary and secondary school halls;
 - o staff rooms, offices, administration and meeting rooms; and
 - o storage areas, student and staff amenities;
- sporting field and outdoor play areas;
- upgrades to Catherine Fields Road including road widening, new turning lane and bus bay;
- temporary on-site wastewater management including on-site sewage treatment plant;
- maximum of 138 on-site car parking spaces and 30 drop-off and pick-up spaces;
- landscaping and public domain works; and
- staged increase in student numbers to a maximum of 1580 students by 2040 including 60 ELC students, 20 SSP students, 840 primary school students and 660 secondary school students.
