Roads

Catherine Field road like so many roads in the area are your typical country road countless pot holes, no curb and guttering, no storm water drainage so when it rains the roads flood. Most roads around here flood leaving people stranded unable to get out, having to wait until the water subsides

Increased traffic will be an ~~nightmare~~ along Catherine Field Road ~~can't~~ handle the increase in the ~~traffic~~ traffic, the road is used by locals as a by pass from Camden Valley Way to miss being caught up in the daily morning and afternoon heavy traffic. If this school/college goes ahead that traffic will be forced into using Camden Valley Way increasing the traffic along that major road. Passing cars turning into the school hallways will make the
