Description of proposal	

Increase in throughput of waste at the existing Eastern Creek Recycling Ecology Park from 2,000,000 tonnes per annum (tpa) to 2,950,000 tpa and upgrade of supporting infrastructure, including: new exit connections to the Honeycomb Drive extension and Kangaroo Ave; installation of weighbridges; upgrade of internal roads and carparking; and a new skip bin maintenance and manufacturing workshop.
