Description of the development consent

The Maxwell Underground Coal Mine, includes:

- extraction of up to 8 million tonnes per annum (Mtpa) of run-of-mine (ROM) coal until 2047 using underground mining methods; and
- construction and operation of ancillary infrastructure and water infrastructure to support mining operations.

Description of proposed modification

The proposed modification application involves:

- reorientation of approved longwall panels;
- reduction in width of some of the longwall panels in the Woodlands Hill Seam;
- repositioning the upcast ventilation shaft and associated infrastructure; and
- development of ancillary infrastructure for the repositioned ventilation shaft site.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (Department) has received an application to modify the abovementioned approved State significant development.
