Description of the development consent

Upgrades to Hastings Secondary College Port Macquarie Campus, including refurbishment of parts of two existing buildings, provision of a two storey Creative and Performing Arts (CAPA) building, joint use PCYC facility, covered outdoor learning area (COLA), new covered walkways and lift connections, and upgrades to the school entrance and signage. Associated works include demolition, tree removal, earthworks, landscaping, stormwater works and services upgrades.

Description of proposed modification

The modification application seeks approval for design changes, including but not limited to the following:

- the entry of Building A and the adjoining covered walkways
- Building B, including refurbishment of the first floor level
- the CAPA building, including new rooftop plant equipment and external stairs
- deletion of the approved Building L refurbishment works
- landscape design, including additional tree planting
- building facade materials and treatment.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (the Department) has received an application to modify the abovementioned approved State significant development (SSD). The application and accompanying documents (including the Modification report) are on exhibition from **2 August 2022** until **15 August 2022**.
