

EXHIBITION OF STATE SIGNIFICANT INFRASTRUCTURE APPLICATION

INLAND RAIL – ILLABO TO STOCKINBINGAL

Description of proposed infrastructure

Construction and operations across a total extent of approx. 42.5 kilometres, including 39 kilometres of new, single track standard gauge railway between Illabo and Stockinbingal in regional NSW, involving:

- track vertical alignments on existing ground level, on embankments and in cuttings
- eight new bridges at watercourses, two road overbridges and one grade separated (road over rail at Burley Griffin Way)
- one crossing loop and associated maintenance siding
- construction of new level crossings, alterations of existing level crossings, and stock crossings
- one major drainage diversion to collect and transport stormwater away from the rail line
- realignment of a 1.4 kilometre section of the Burley Griffin Way to provide a road over rail bridge at Stockinbingal
- works including installation and upgrade of new and existing culverts, upgrades to existing track for tie-in works, and removal of redundant sections of track.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment has received a State Significant Infrastructure (SSI) application for the abovementioned proposal. The application, Environmental Impact Statement (EIS) and accompanying documents are on exhibition from **Wed 14 September 2022** until **Wed 26 October 2022**. Controlled Action under Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act)

The Commonwealth Minister for the Environment has decided that the proposed development is a "controlled action" under the EPBC Act. The EPBC Act Part 3, Division 1 controlling provisions are Sections 18 and 18A (Listed threatened species and communities).

The proposed development will be assessed under Part 5 of the Environmental Planning and Assessment Act 1979. The assessment will be in accordance with the Bilateral Agreement between NSW and the Commonwealth, made under the EPBC Act. The assessment will be done in the manner specified in Schedule 1 of the Bilateral Agreement. This means the project will be assessed against the requirements of both acts.
