### Description of proposal

The State Significant Development (SSD) application seeks approval for the following:

- Site preparation works including demolition of existing buildings.
- Construction of a mixed use co-living housing development ranging in height from five (5) to seven (7) storeys with a total gross floor area of 7,006.4m<sup>2</sup>, comprising:
  - o 216 co-living rooms, communal living areas, and ground level and rooftop communal open space
  - ground and first floor commercial/retail uses, including co-working office space
  - basement parking.
- Landscaping works, extension and augmentation of services and infrastructure as required.

The Department of Planning and Environment (the department) has received a State significant development (SSD) application for the abovementioned proposal.
