Description of proposal

- Staged development of a new school campus (Blessed Carlo Catholic School) to accommodate 390 (Kindergarten – Year 12) students and 50 staff, comprising:
- four one to two storey buildings to accommodate the following:
 - indoor gymnasium, multipurpose sports facilities, music rooms, performance areas and canteen;
 - workshop spaces, laboratories and various technology areas;
 - multipurpose learning spaces, administration areas, collaboration areas and staff rooms;
 - associated tree removal, landscaping works, playing fields, hard surface sports courts and amphitheatre;
 - a chapel;
 - car parking including internal drop-off/-pick-up areas; and
 - delivery in four stages.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development. The Department of Planning and Environment (the department) has received a State significant development (SSD) application for the abovementioned proposal. The application, environmental impact statement (EIS) and accompanying documents are on exhibition from **Thu 10 November 2022** until **Wed 07 December 2022**.
