# **HUNTER STREET EAST OVER STATION DEVELOPMENT**

## **Description of proposal**

The concept development application seeks approval for an over station development above the Sydney Metro Hunter Street East site, including establishing:

- maximum gross floor area of 84,223m2, including approx. 81,769m<sup>2</sup> of commercial uses, 1,454m<sup>2</sup> retail uses and 1,000m<sup>2</sup> station uses;
- maximum building envelopes, including heights and setbacks, for a new tower up to a maximum height of RL 269.1 (approx. 58 storeys) accommodating the eastern station entrance of Sydney Metro (subject to separate infrastructure application SSI 22765520);
- maximum of 70 car parking spaces to be shared with the West over station development; and
- arrangements for loading spaces, servicing and utilities.

Note: the concept proposal does not seek approval for any construction works.

#### About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (the department) has received a State significant development (SSD) application for the abovementioned proposal. The application, environmental impact statement (EIS) and accompanying documents are on exhibition from **Monday 5 December 2022** until **Monday 30 January 2023**. At the time of publishing this advertisement, the Minister for Planning has not directed that a public hearing should be held.
