Description of proposal

- Upgrade of the Great Western Highway between Blackheath and Little Hartley comprising the construction of 11 kilometre twin tunnels and surface road upgrade work to connect the tunnels to the surrounding road network.
- Tunnel operation infrastructure including a tunnel operations facility at Blackheath, air ventilation systems, water management and treatment facilities, lighting and signage.
- 14 kilometre pipeline between Little Hartley and Lithgow for construction and operational water supply.

The proponent has requested that the Minister for Planning declare the project as critical State significant infrastructure.

About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning and Environment (the department) has received a State significant infrastructure (SSI) application for the abovementioned proposal. The application, environmental impact statement (EIS) and accompanying documents are on exhibition from **18 January 2023** until **1 March 2023**.
