#### Description of proposed modification

The Section 4.55(2) modification seeks:

- changes to the Remediation Action Plan to include the retention of additional fill on site and a revised capping strategy
- alterations to site levels, landscaping and retaining walls
- a reconfiguration of service areas and storage sheds
- an extension to construction hours to:
  - o allow work on Sunday and public holidays between 7 am and 5 pm
  - allow internal works within the building between 5 pm and 7 am, Monday to Sunday
