
Our small annual exhibition has been the grateful financial beneficiary of the support of the Bendemeer Renewal Energy Hub (BREH) that has enabled us to significantly broaden the appeal of our Art Exhibition to a broader creative community in terms of prize money, new categories such as photography and junior art work sections. We see this role as imperative to enable us to provide nurturing support to budding artists far and wide of our small community. There is wide acknowledgement from many significant established artists of the major role these small exhibitions have played in the progression of their own personal career path. Indeed the winner of our 2023 Major Art section used her own prize money to help frame her first individual exhibition and we watch with excitement the progression of Janna's own career.

The context of this story is that major sustainable developments that are in accord with International, National, State and Local environmental objectives we see as a "once in a generation opportunity" to reinvigorate small rural communities like ours. Some members of our committee who have an active interest in the broader welfare of the Bendemeer community have read through all the State Significant Development application Environmental Planning Assessment report to make our own assessments of the planned solar farm.

The broad consensus of this review is that the site has been wisely chosen offering minimal broad visual impact to the Bendemeer community, the site assessment indicates there are no significant site constraints to the proposal and that the project will generate significant economic benefits to our region.

We are sympathetic to objections raised by some of the immediate neighbours but believe that appropriate development setbacks and landscaping can mitigate the visual impact of the solar arrays. We question some of the more spurious objections that appear to be supported by some more political fossil fuel motives trying to detract from what appears a progressive contribution to minimising a climate problem at the forefront of most informed people.

The opportunity to generate solar energy to support in excess of 70,000 homes whilst injecting huge amounts of capital into our local community is deserving of our unqualified support.
