Description of proposal

The application seeks approval for a seniors housing development comprising:

- construction of a 5 storey residential care facility comprising 41 beds, kitchen, ancillary services, rooftop communal open space
- construction of 58 independent living units in 2 x 4 storey buildings fronting Parraween Street and an 8 storey building fronting Gerard Street including on-site ancillary services, café and rooftop open space areas
- construction of a two-level basement containing 134 car parking spaces
- new public park providing through site access between Parraween and Gerard Streets
- landscaping, public domain works and the adaptive reuse of 9 cottages located on Parraween Street
- demolition and site preparation works.
