My name is Karen Milbourne of Parkes road Moss Vale NSW 2577. I am writing to you regarding the Project for Plasrefine Recycling Facility proposal for Moss Vale , Application no-SSD-9409987.

I completely object to this project as it is the wrong site for Moss Vale and its surrounding area.

I OBJECT this proposal for the following reasons-

- 1. The proposed site is within meters of residential housing and the immediate town of Moss Vale.
- 2. The new access route provided by WINGERCARRIBEE Shire Council to the proposed site, to much disappointment, is no more than a small road designed for horse and cart. There is no way heavy transport can operate safely both ways let alone pass one another. Turning off Brookdale Road right onto Berrima Road there would need to be a STOP sign for these trucks. Berrima Road is now a leading arterial road out of Moss Vale to get to other towns in the area as in Moss Vale township the roads are now grid locked most days of the week.
- 3. Coming off Taylor Avenue New Berrima, the trucks will be travelling through a 50km speed zone ending at the T-Intersection to enter Berrima Road at a Give Way sign. Upon turning right into Berrima Road only progressing 50 metres, these trucks, big doubles, whatever, will have to queue up to a STOP SIGN at the operational railway crossing which serves into Boral Cement Works. **STOP MEANS STOP. THE LOCAL POLICE DO WELL OUT OF THIS CROSSING.**
- 4. The amount of congestion coming into Moss Vale from Berrima Road will now be an absolute disaster for all trying to get in and out of Moss Vale, also the banking up of heavy haulage trucks though New Berrima.
- 5. In the aforementioned traffic nightmare , if this disaster of a project gets approved not if but **WHEN it goes up in smoke** where and how do we all evacuate to.
- 6. In this revised proposal also nothing is mentioned about the amount of waste water and sludge to be transported through Moss Vale township onto Bowral to the tip for dumping.

This Proposed Recycling Facility is a total kick in the teeth for Moss Vale ITS THE WRONG SITE FULL STOP. Theres more to object too, but I sincerely hope that someone with common sense will prevail and look somewhere else FOR THIS PROJECT.
