#### Description of proposal

The proposal as originally advertised was:

Construction of a wastewater treatment plant and associated sewage and reuse mains.

The advertised proposal would have the following amendments made:

- A reduction of the laydown area adjacent to the proposed WWTP to reduce impacts upon biodiversity values and the surrounding wetland areas
- Amendment of pipelines to avoid impact on the existing BioBanking site
- Minor realignment of underbore locations to better align the design with existing services and reduce property impacts
- Amendments to sewer pumping stations and associated pipelines to improve network connectivity
- Minor amendment to construction footprint width at some locations on the pipeline network to provide sufficient access for construction vehicles and equipment
- Minor amendment to pipelines to avoid construction of mains within the airport, to avoid conflict with new developments and to move further away from the existing Port Macquarie Race Club.

#### About the exhibition

An exhibition process allows any individual or organisation to have their say about a proposed development.

The Department of Planning, Housing and Infrastructure (the department) has received an amended application for the abovementioned State significant infrastructure (SSI) proposal.
