In response to the Departments request for comment dated the 20 January 2011 in relation to Modification Application 1, Council is now in the position to submit the following comments for your consideration.

Furthermore, Council notes the Department's advice that Modification Application 2 has been withdrawn.

In relation to the 3 conditions proposed to be amended via Modification Application 1, the following comments are provided below.

Condition B1 – no objection to modifying the timing of the basin approval to coincide with the stage that the works are required.

Condition B4 – the lack of physical Road Reserve is acknowledged and therefore the whole of the shared path cycleway cannot be completed until land negotiations are resolved. Council agrees that this condition needs modification. It is suggested that rather than link the timing of construction with stage numbers it is proposed that the condition read that 'construction occurs prior to release of stage 7 or 100 lots (not bulk earthworks/clearing), whichever occurs first.

B14 – proposed changes noted and Council has no major issue with staging proposed, particularly when a detailed Landscape Master Plan has previously been adopted for the entire site. Further, it is suggested that Street trees at each stage is satisfactory.

I refer to your letter dated 20 January 2011 (Your reference: 06-0250) regarding the subject application for modification to Ministers approval forwarded to the RTA for consideration

RTA Responsibilities and Obligations

The RTA's primary interests are in the road network, traffic and broader transport issues, particularly in relation to the efficiency and safety of the classified road network, the security of property assets and the integration of land use and transport.

In accordance with the *Roads Act 1993*, the RTA has powers in relation to road works, traffic control facilities, connections to roads and other works on the classified road network. Nelson Bay Road (MR108) is a classified (State) road and RTA concurrence is required for connections to the road with Council consent, under Section 138 of the Act. Council is the roads authority for this road and all other public roads in the area.

RTA Response and Requirements

The RTA has reviewed the information provided and has no objections to the proposed modifications. It is understood that the proposed modification to *Condition B4* involves deferring the construction of the shared cycleway / footpath from Stage 4 to Stage 7 of the subdivision development. All other requirements for *Condition B4*, as listed in the Ministers approval dated 28 June 2010, shall remain the same except for who would manage the design and construction of the cycleway / footpath. The proposed shared cycleway / footpath this is a Council requirement and responsibility. The condition should read '.....in accordance with the requirements of Council, in consultation with the RTA.'

Council should consult with the RTA where there is a potential interface between the road pavement and the shared cycleway / footpath.

DECCW has undertaken a review of the documentation provided and has no objection to the modifications sought by the proponent.

However, DECCW notes that the Proponent has referred to the onsite storage of a substantial volume of fill (90,000m³) and takes this opportunity to remind Aspen Group of its responsibilities under Schedule 1 of the *Protection of the Environment Operations* (POEO) *Act* 1997. It is the Proponents responsibility to ascertain whether or not any of the proposed activities (such as bulk earthworks) are deemed a Scheduled Activity under this Act. If any of the activities are deemed scheduled activities, the proponent will require an Environment Protection Licence (EPL) issued by DECCW under the provisions of that Act.
