Notice of a Modification Application for consent to carry out State Significant Development under Section 4.55(2) of the Environmental Planning and Assessment Act 1979 (NSW) – Cadia Valley Operations.

Cadia Holdings Pty Limited (CHPL) (ABN: 95 062 648 006), is the owner and operator of Cadia Valley Operations (hereafter referred to as Cadia). Cadia is an existing approved mining operation which includes the Cadia East Underground Mine, the Cadia Hill Open Cut Mine, the Ridgeway Underground Mine, the concentrate dewatering facility east of Blayney, known as the CVO Dewatering Facility, and a wide range of ancillary and supporting infrastructure. Cadia is located approximately 25 kilometres south-west of Orange, in the Central Tablelands of New South Wales (NSW).

CHPL has made an application for Cadia (the Modification Application) to the Minister for Planning and Public Spaces for consent to carry out the Cadia Northern Tailings Storage Facility (NTSF) Buttress Optimisation (Modification 16) under Section 4.55(2) of the Environmental Planning and Assessment Act 1979 (NSW).

This notice of the Modification Application for consent to carry out Modification 16 is given by CHPL in accordance with section 98(4)(b) and 98(5)(b) of the Environmental Planning and Assessment Regulation 2021 (NSW).

Project Description:

Modification 16 principally proposes the use of recovered sand to buttress the southern wall of the NTSF along with emplacing/stockpiling excess recovered sand within the approved Southern Tailings Storage Facility disturbance footprint. In addition, Modification 16 would involve integrating the recovered sand demonstration embankment approved under Modification 15 to PA 06_0295 with the proposed NTSF southern wall recovered sand buttress, with the integrated structure to remain and form part of the final landform. These works would be undertaken 24 hours a day, seven days per week and the already approved disturbance footprint.

As required by the Department of Planning, Housing and Infrastructure, the Modification Application for Modification 16 and accompanying documents can be accessed on the NSW Major Projects Planning Portal (<https://www.planningportal.nsw.gov.au/major-projects/projects>).
