Hi Rod,

finally had a chance to review the plans.

the following appear to be issues.

(1). The culverts appear to be very narrow relative to the 1:100 year flood footprint. What is the capacity of the culverts before they start to cause detention ? or.

(2). On a similar concern the narrowness would appear to cause a high concentration of flow on the downstream side, which can cause long term instability issues for the creek.

(3). There is no "naturalised base".

(4).there is no wet and dry cells for fauna passage.

I've attached a good example of issues 3 and 4.

Not sure if we need to meet if you can satisfactorily address the above.
