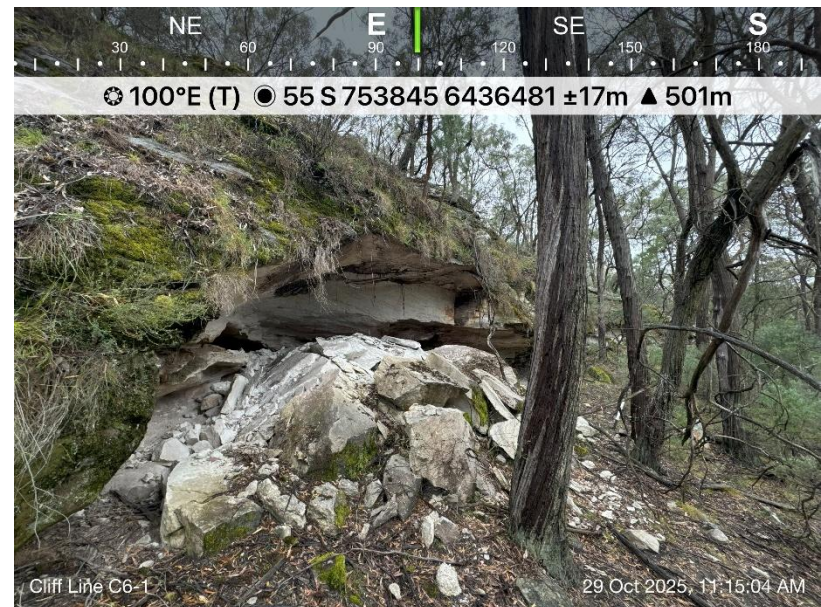

Site C6-1: Pre-Mining Inspection – 15 August 2022

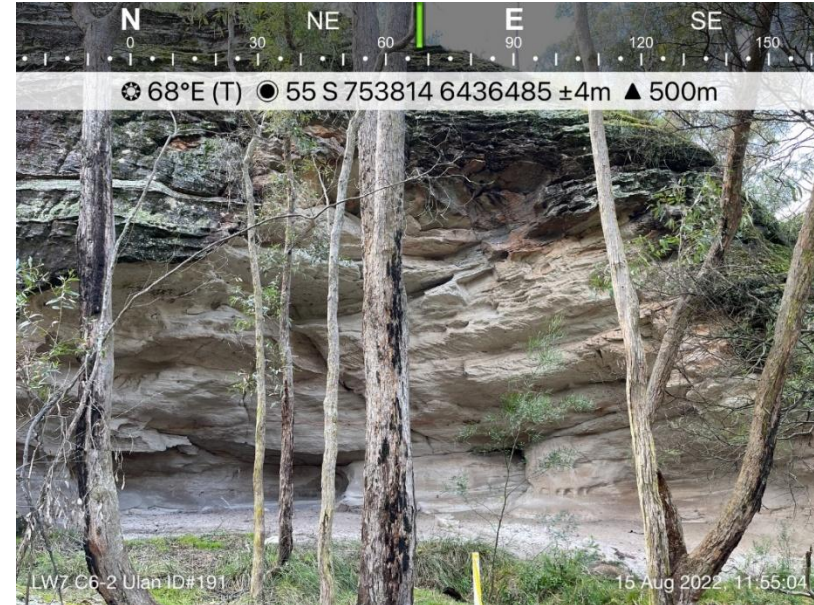


Site C6-1: Post Mining Inspection – 29 October 2025

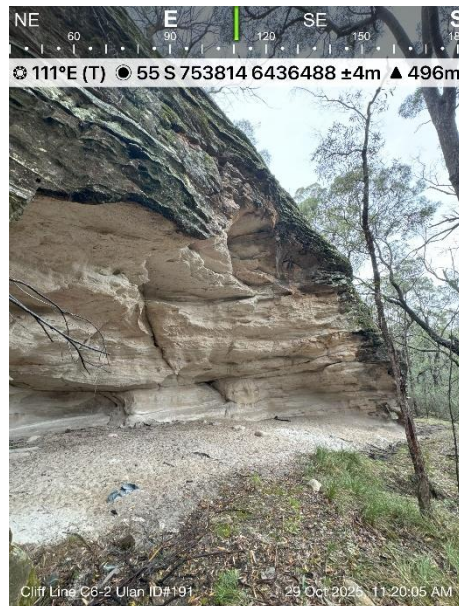

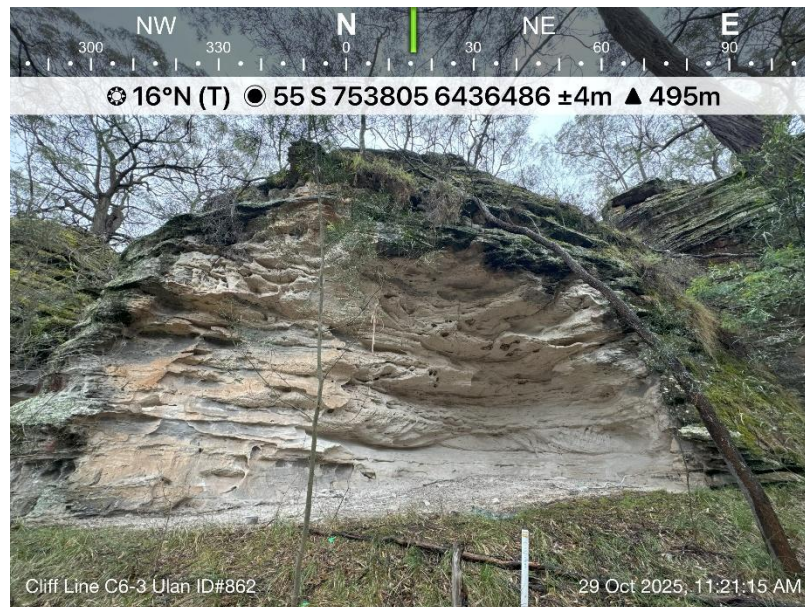
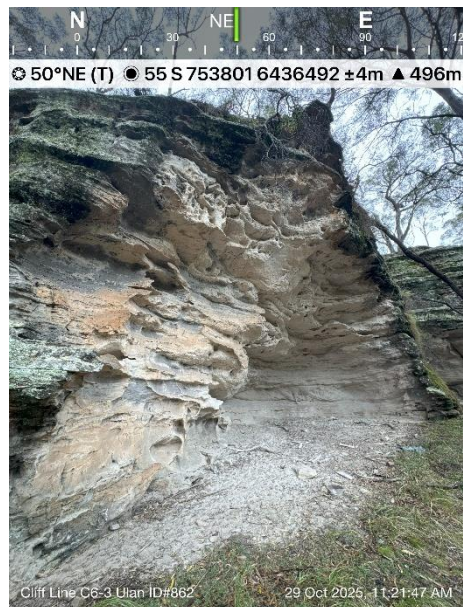

Site C6-3 & Ulan ID#862: Pre-Mining Inspection – 15 August 2022

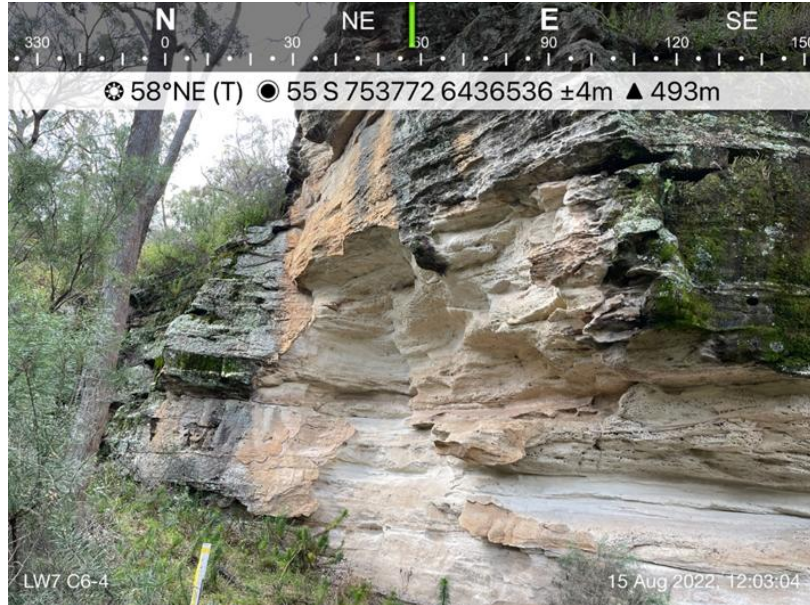


Site C6-3 & Ulan ID#862: Post Mining Inspection – 29 October 2025

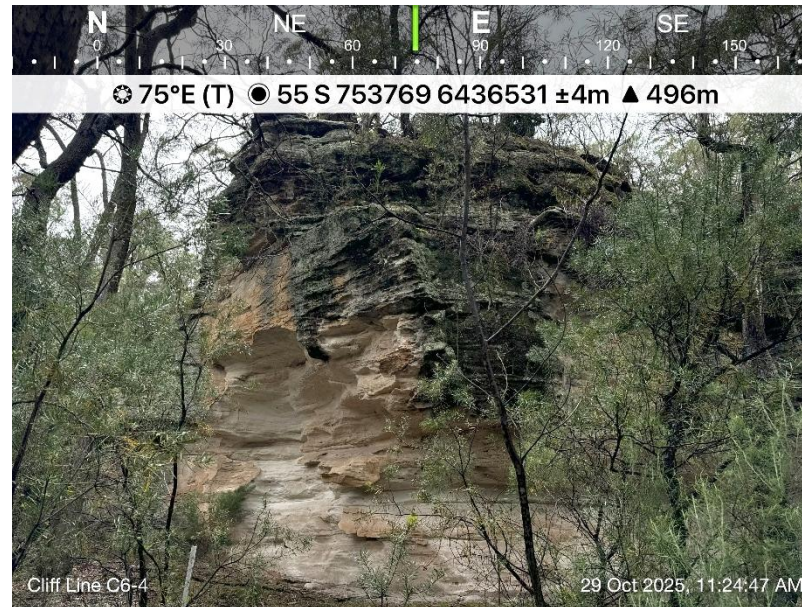
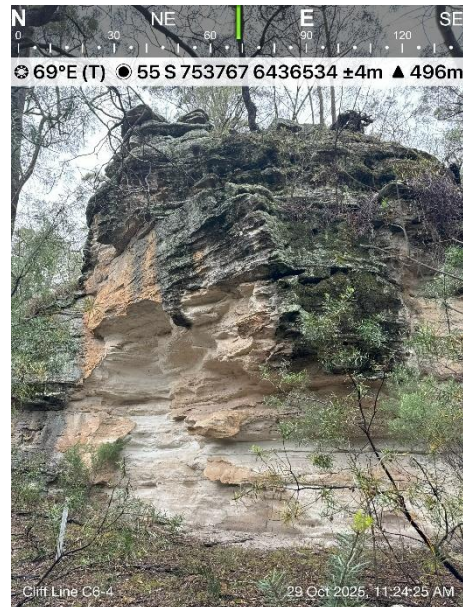

Site C6-4: Pre-Mining Inspection – 15 August 2022

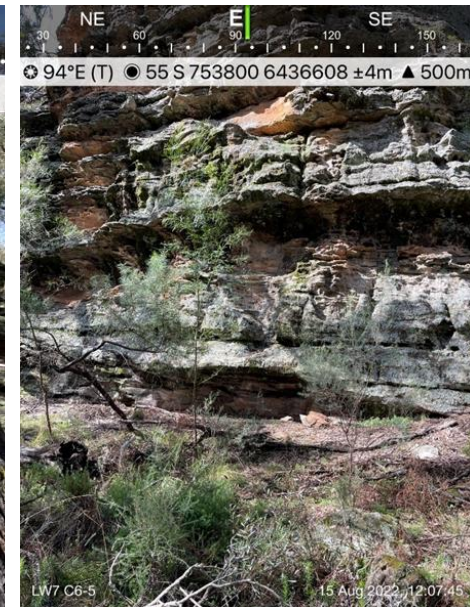


Site C6-4: Post Mining Inspection – 29 October 2025

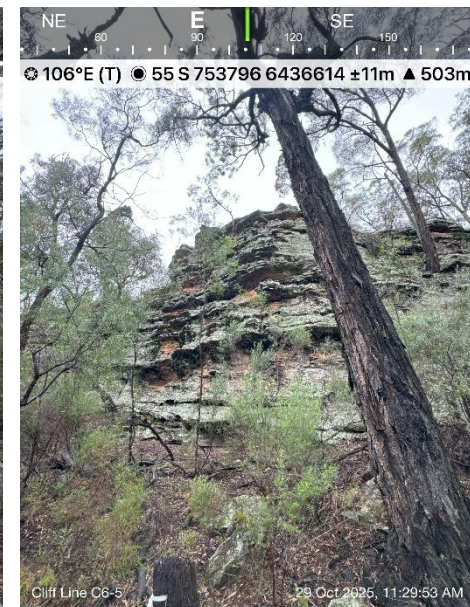
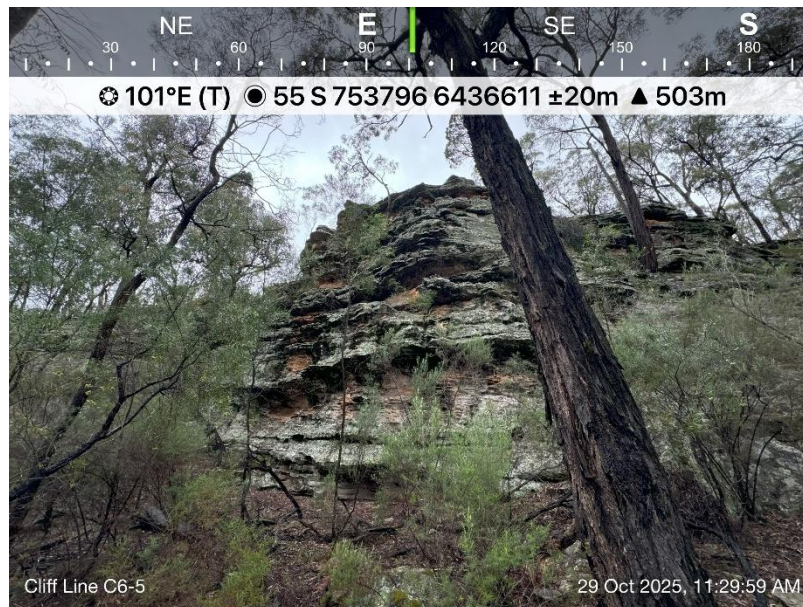

Site C6-5: Pre-Mining Inspection – 15 August 2022

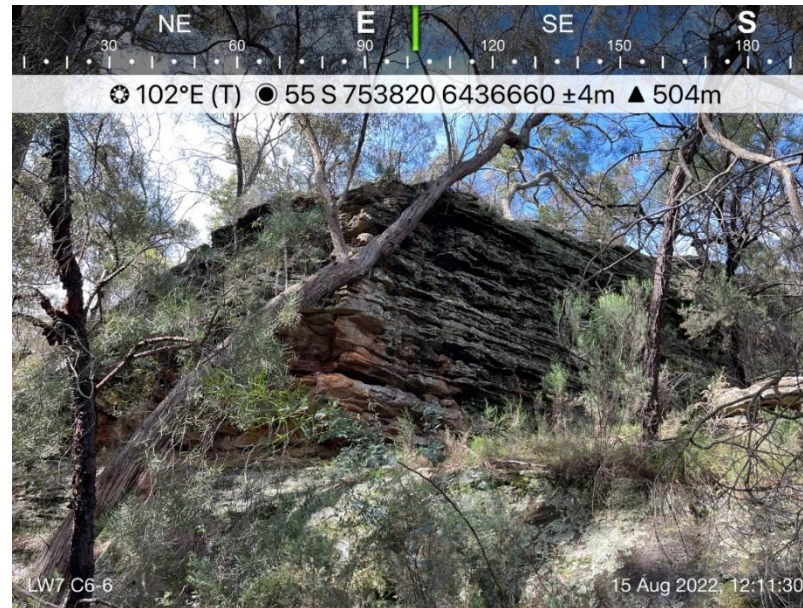


Site C5: Post Mining Inspection – 29 October 2025

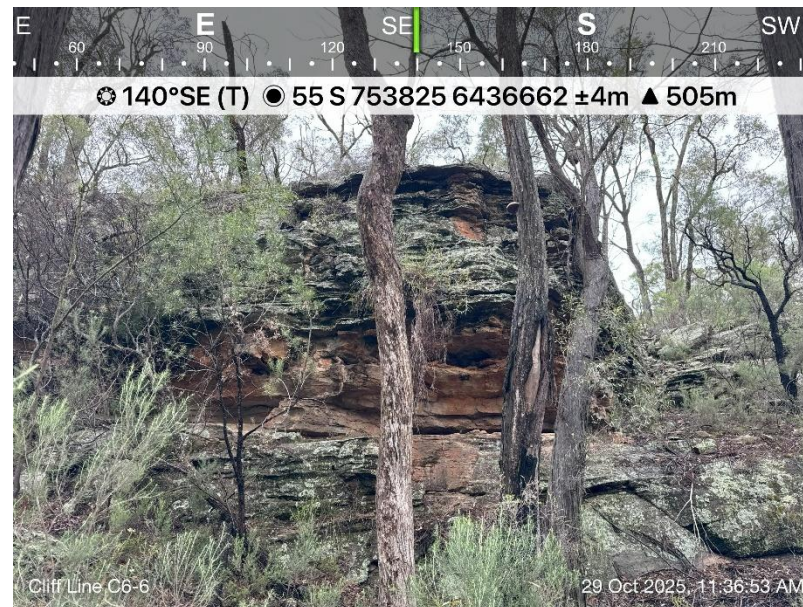
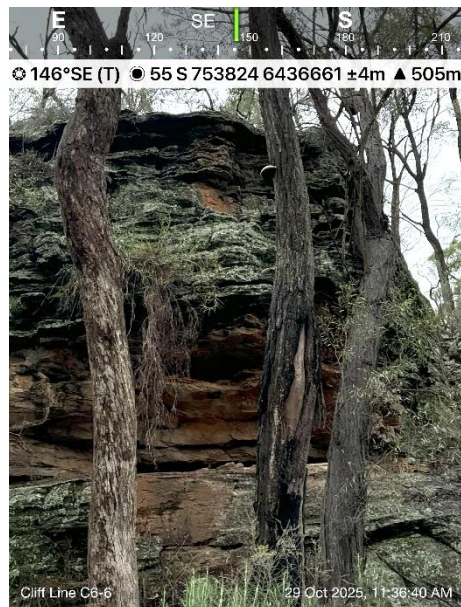

Site C6-6: Pre-Mining Inspection – 15 August 2022

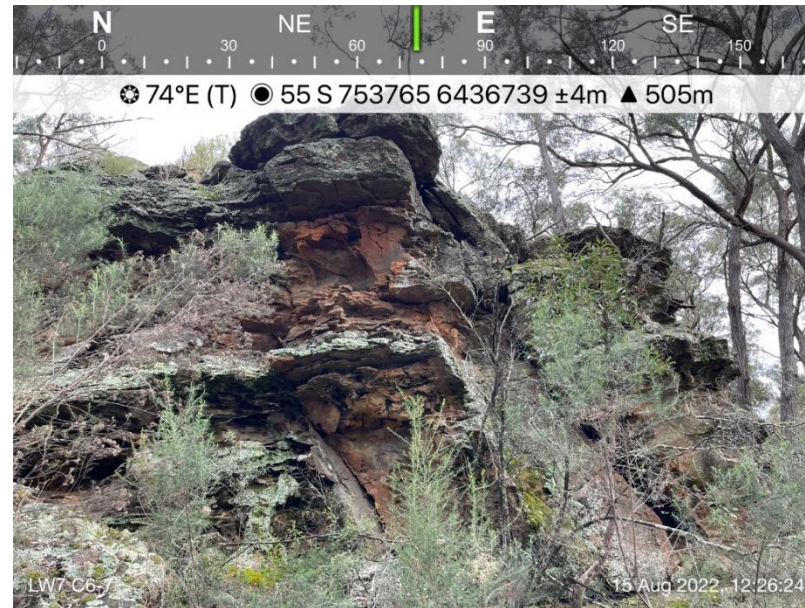


Site C6: Post Mining Inspection – 29 October 2025

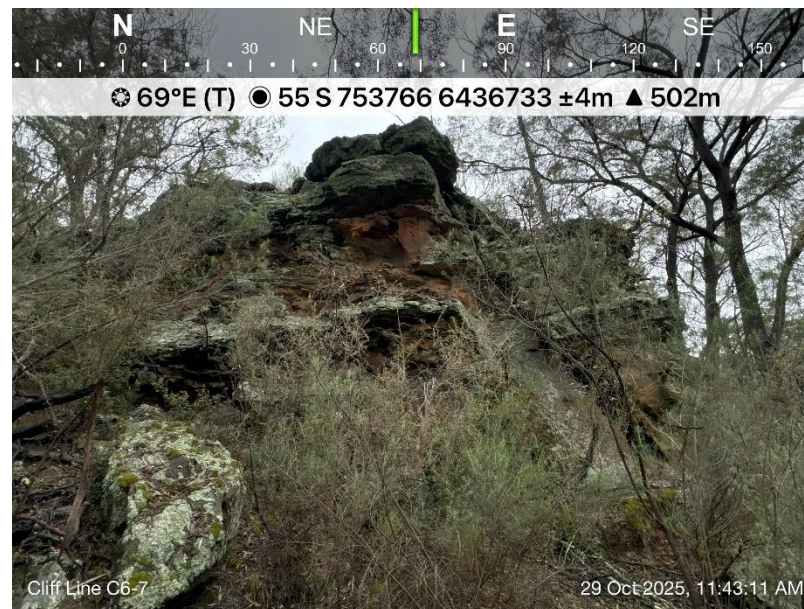

Site C6-7: Pre-Mining Inspection – 15 August 2022

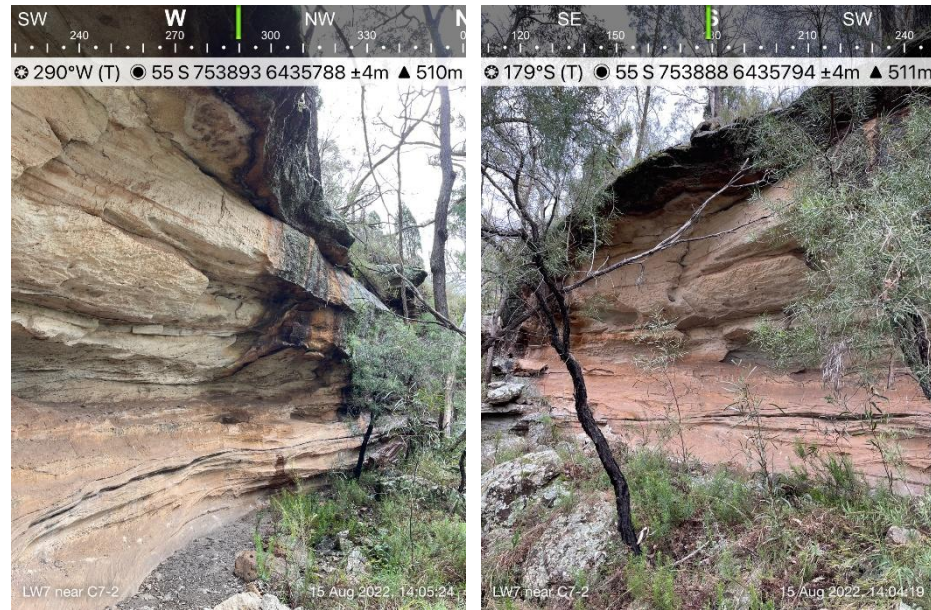


Site C6-7: Post Mining Inspection – 29 October 2025

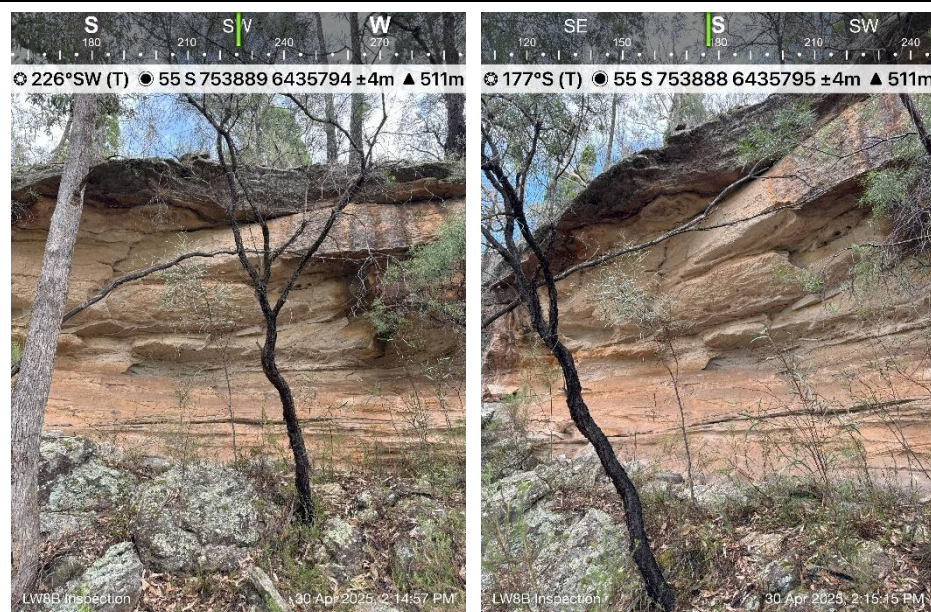

Site C7-1 & Ulan ID#189: Pre-Mining Inspection – 15 August 2022

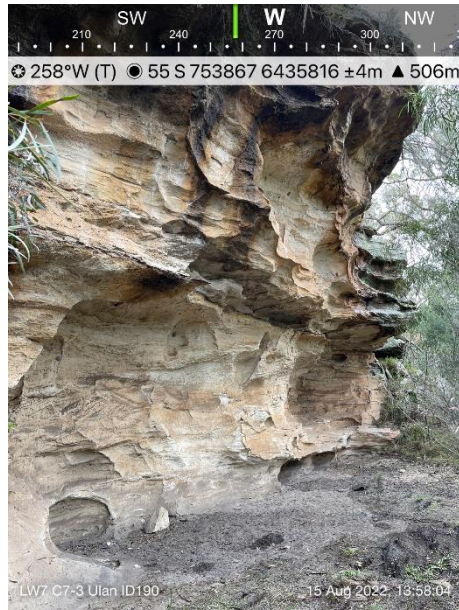


Site C7-1 & Ulan ID#189: Post Mining Inspection – 30 April 2025

Site C9-1 & Ulan ID#271: Pre-Mining Inspection – 23 May 2023

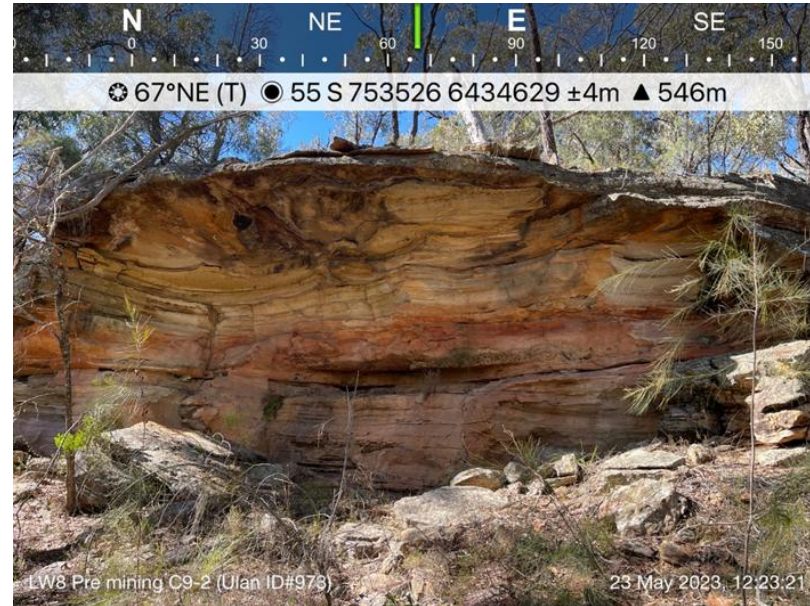
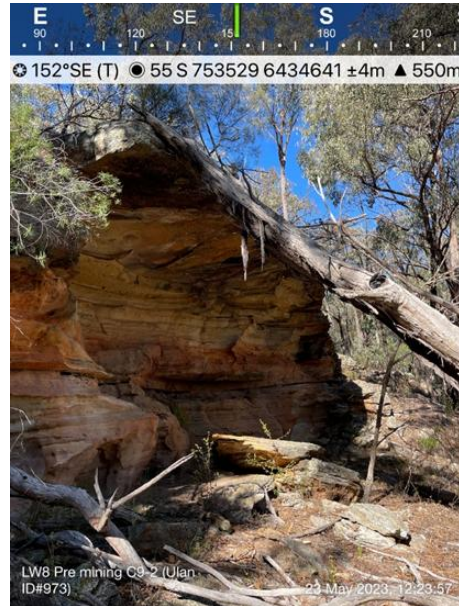


Site C9-1 & Ulan ID#271: Post Mining Inspection – 26 August 2025

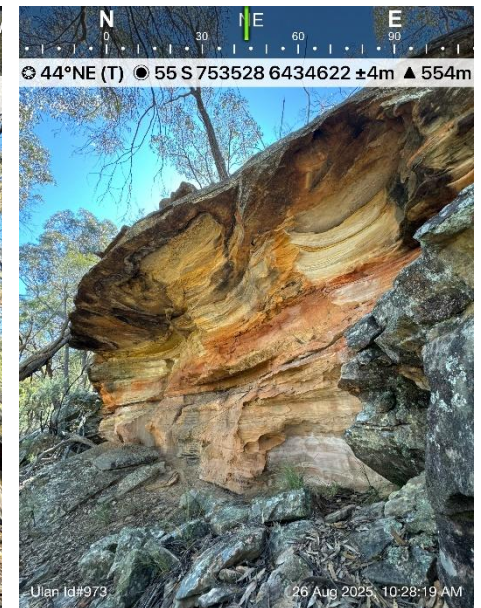
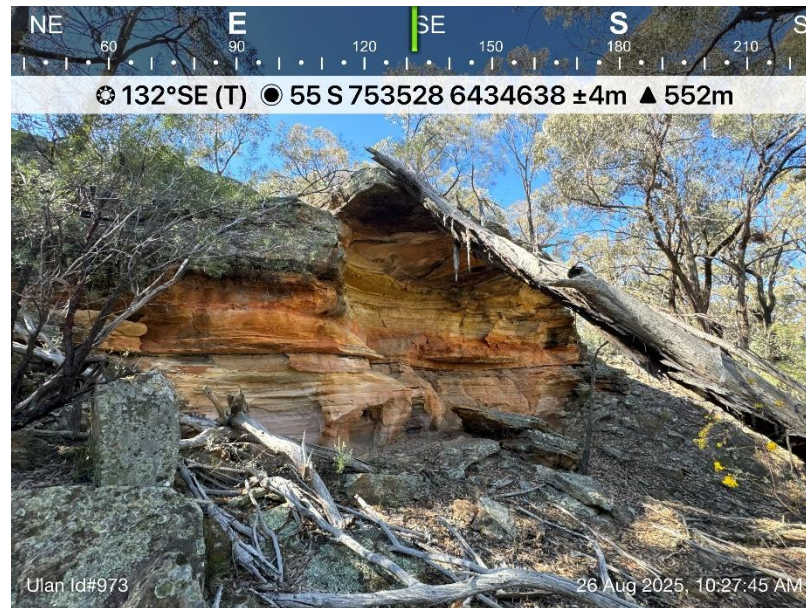
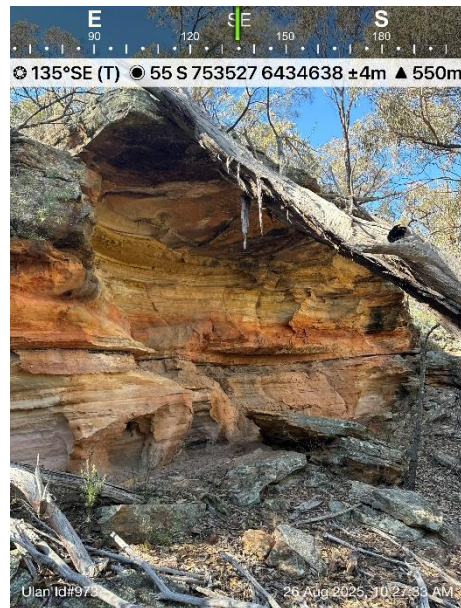

Site C9-2 & Ulan ID#973: Pre-Mining Inspection – 23 May 2023

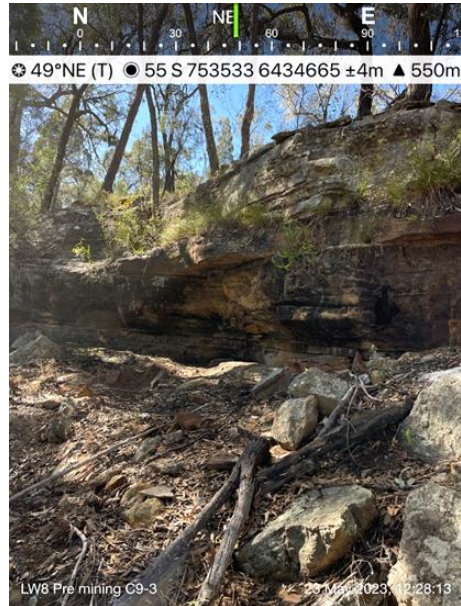


Site C9-2 & Ulan ID#973: Post Mining Inspection – 26 August 2025

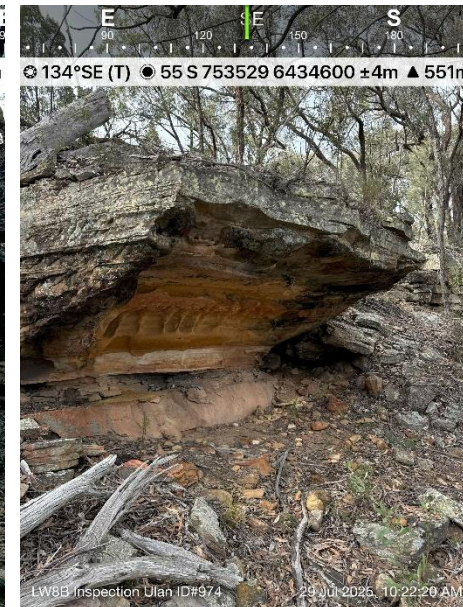
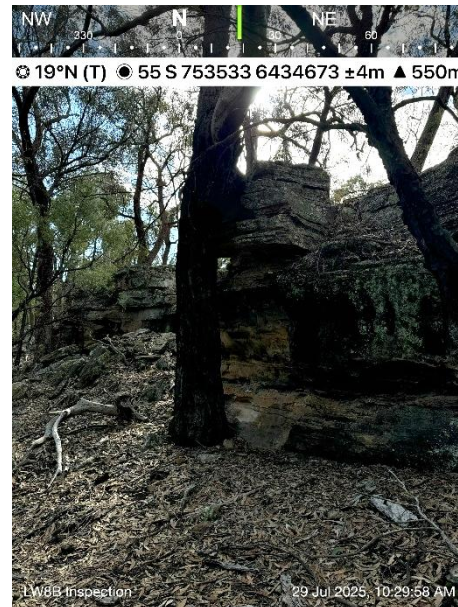
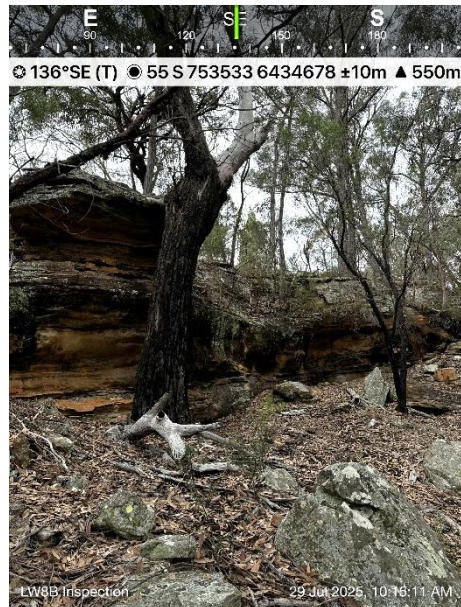

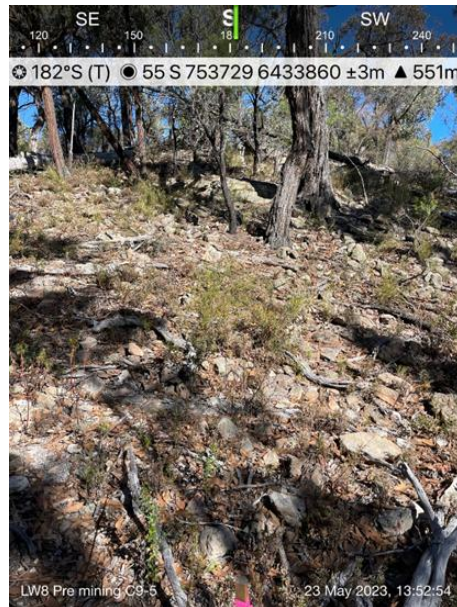


Site C9-4: Post Mining Inspection – 29 October 2025

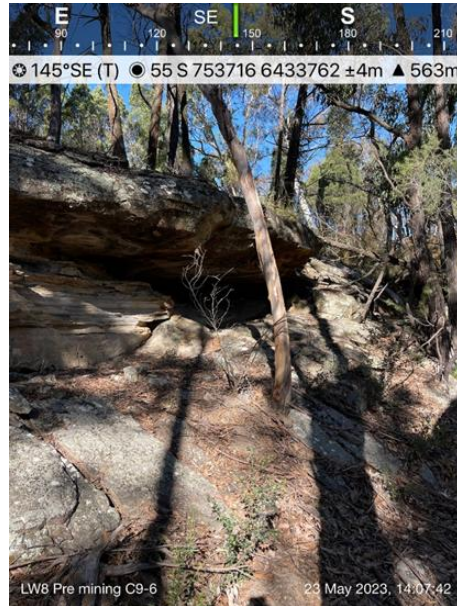


Site C9-5: Post Mining Inspection – 30 September 2025

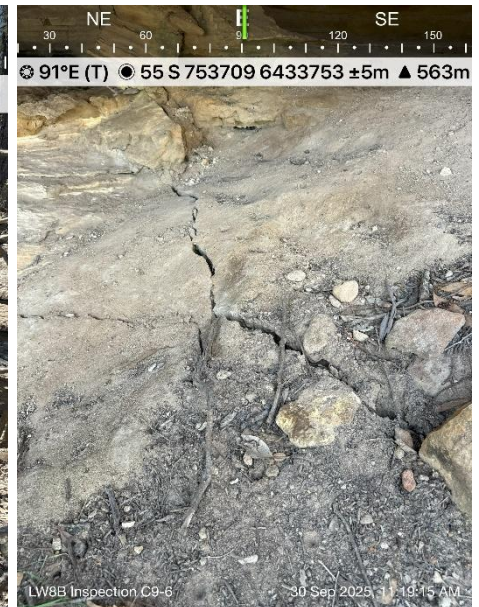
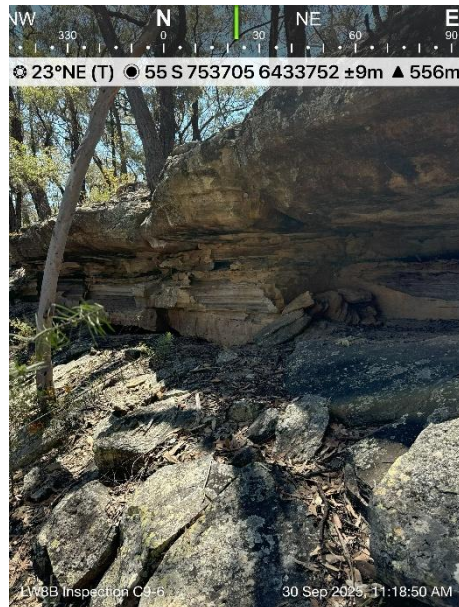

Site C9-6: Pre-Mining Inspection – 23 May 2023

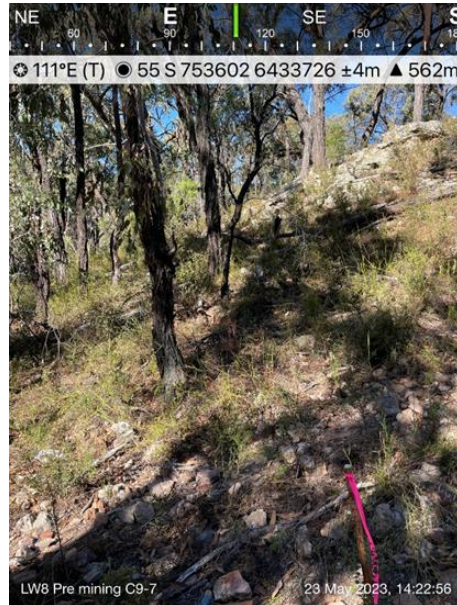


Site C9-6: Post Mining Inspection – 29 September 2025

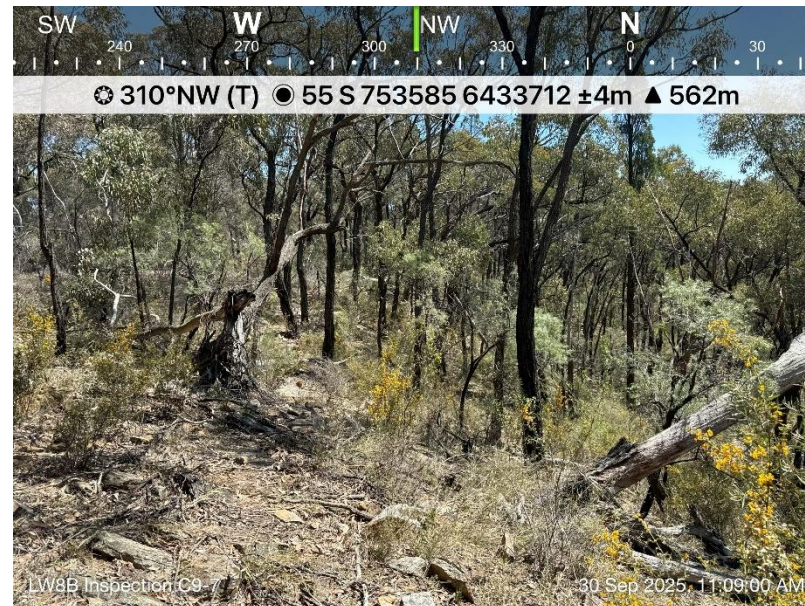

Site C9-7: Pre-Mining Inspection – 23 May 2023

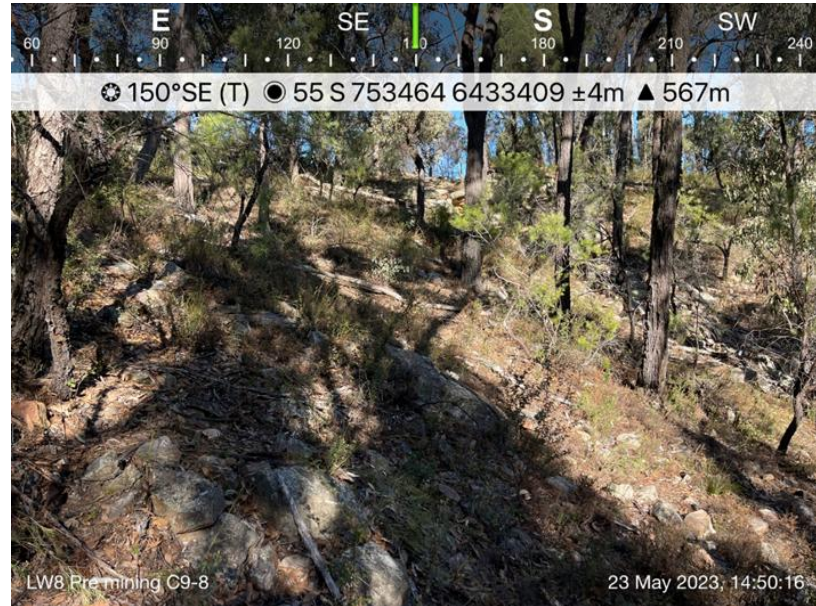
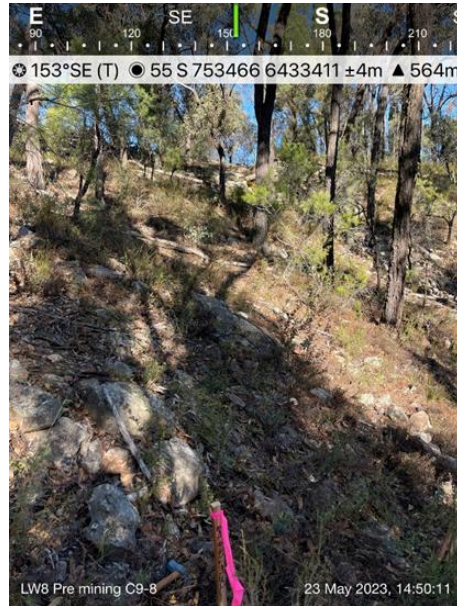


Site C9-7: Post Mining Inspection – 29 October 2025

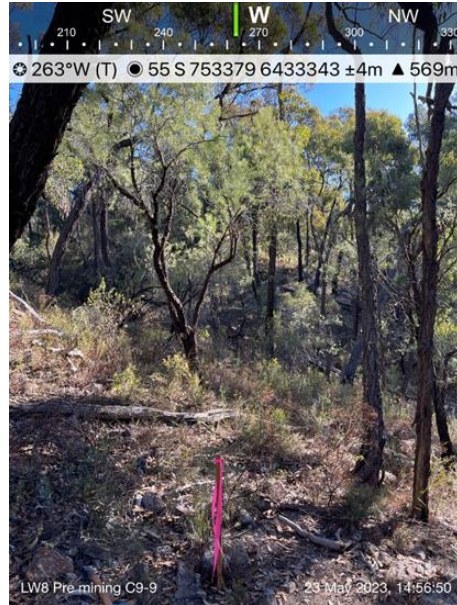
