Dear Mr Cameron,

I am writing to express my deep concern regarding a number of aspects of the Super Yacht Marina Development Application in Blackwattle Bay Glebe.

Please note that as a long time resident, and the occupier of my residence at the time the previous premise (Liquidity) was in operation, I wish to point out that the noise levels from facilities in the bay, is one which requires careful monitoring. It is my understanding that the existing noise constraints as authorised by the 2012 Planning Assessment Committee are scheduled to be removed, and seek your explanation for such a decision. In my opinion this decision would greatly impact residents on the residential side of Blackwattle Bay, and having already established the level appropriate in 2012 it would seem a surprising overturn.

There is also the matter of the increase in Super Yacht capacity from 24 to 43. As the area of the bay where the yachts are presently moored is very narrow, this decision would leave other uses or the area without adequate safety - it would also seem a area of potential congestion for the proposed number of yachts themselves.

In summary the proposed changes are in unbalanced favour of the developer and do not factor in community needs. I therefore wish to lodge my objections as stated above.

To whom it may concern

I am writing to express my concern at the proposed development changes and modifications under consideration in the above matter. This development should be seen in the context of the entire Bays Precinct proposal. The proposed modifications have implications for the future of Glebe Island Bridge, Rozelle Bay and pre-empt the overall master plan for the area.

Under both the Sydney Harbour Plan and Bays Master Plan this area is zoned for maritime use, not as an entertainment precinct which is what the yacht club is shaping up to be.

I note that the developer now wants more outdoor seating, more car parking, and more berths, and is seeking to repeal the noise controls imposed by the Planning Assessment Commission in 2012. We hope you recognise that this has a cumulative effect with major implications for amenity of area.

I note that the changes to the building include increasing carpark space by an extra level which will add to the overall building height. The current building is already a very large and imposing structure.

Allowing the wharf-level forecourt and decks/balconies to be used for outdoor seating may well contribute to a successful private venture, but isn't going to improve the public space or access. It will impact on the residents, the park users, the walkers, the picnicker and the kayakers, rowers who regularly enjoy access to the area.

Increasing the number of yacht berths from 24 to 43 will seriously interfere with the members of the public who enjoy the water at Blackwattle Bay and the hundreds of dragon boat paddlers, the rowers and the kayakers, as well as the boats coming out from the fishmarkets. Rozelle Bay is small and its capacity is already stretched.

Also, increasing the capacity for 36 yacht tenders (from zero) will cause unacceptable acoustic impacts on the residents who already worry about the current noise on the water.

I wish to point out that the Sydney Harbour Regional Environmental Plan (Sydney Harbour Catchment) 005 applies to marina proposals in Sydney Harbour. Under this, Sydney Harbour is recognised as a public resource, owned by the public, to be protected for the public good. The public good has precedence over the private good whenever and whatever change is proposed for Sydney Harbour or its foreshores.

The protection of the natural assets of Sydney Harbour has precedence over all other interests. For this reason, I am requesting that more consultation is undertaken with the public before this development proposal is approved.
