Review of Strategies, Plans and Programs following submission of 2020 Annual Review.

Ravensworth Operations submitted the Annual Review (2020) for the Complex to the Department of Planning, Industry and Environment (DPIE) (in accordance with Condition 3, Schedule 5 of Project Approval 09_0176 and Condition 2, Schedule 4 of Development Consent DA 104/96) on 31 March 2021.

Condition 4, Schedule 5 of Project Approval 09_0176 and Condition 3, Schedule 4 of Development Consent 104/96 requires (underline for emphasis):

Within 3 months of:

- (a) the submission of an annual review under condition 3 above;
- (b) the submission of an incident report under condition 6 below;
- (c) the submission of an audit under condition 8 below; and
- (d) any modification to the conditions of this approval the Proponent shall review, and if necessary revise, the strategies, plans, and programs required under this approval to the satisfaction of the Secretary.

Within 3 months of:

- (a) the submission of an annual review under condition 2 above;
- (b) the submission of an incident report under condition 5 below;
- (c) the submission of an audit under condition 7 below; and
- (d) any modification to the conditions of this approval the Proponent shall review, and if necessary revise, the strategies, plans, and programs required under this approval to the satisfaction of the Secretary.

The 2020 Annual Review found that the currently approved Ravensworth Complex strategies, plans and programs were compliant with the conditions of Project Approval 09_0176 and Development Consent 104/96.

The findings and recommendations from the IEA (2018) including the status of actions is provided in the table below. Ravensworth is currently undertaking revisions of several EMPs, in particular, the EMPs listed in Table 1 below.

Aboriginal Cultural Heritage Management Plan	<p><i>The ACHMP will be revised to include a salvage recovery procedure in accordance with Schedule 3, Condition 42 of Project Approval 09_0176.</i></p> <p>The ACHMP was approved by DPIE on the 19 February 2021.</p>
Biodiversity Management Plan	<p><i>Minor updates to the BOMP are required to include reference to the Ravensworth Complex topsoil management/soil resource salvage procedure.</i></p> <p>NSW BCD and the DPIE provided comments to Ravensworth Complex on the BOMP in 2020 and 2021 respectively. The revised BOMP is due to be submitted to DPIE for approval in June 2021.</p>

The following management plans (last approved in 2018) for the Ravensworth Complex will also be reviewed in 2021 to include minor updates to monitoring locations, procedures and other general updates.

- Noise Management Plan;
- Air Quality and Greenhouse Gas Management Plan; and
- Environmental Management Strategy.
