Leard State Forest is the largest single remnant of native vegetation left on the heavily-cleared Liverpool Plains. It is home to 22 threatened plant and animal species, including owls, bats and birds, and contains one of the largest remaining stands of the nationally-endangered Grassy White Box ecosystem.

It is also home to a range of newly-discovered and unique freshwater invertebrates that depend on healthy groundwater.

Collectively, these mines will open-cut two-thirds of this invaluable forest, and replace it with coal mines and dubious ?offsets?. This public forest, with immeasurable benefits to the community, will be destroyed forever for private gain. The fascinating underground species that depend on healthy groundwater won?t stand a chance.
