## Dear Sir ...

In regard to the above proposal to build 298 units at the above address, I would like to question the wisdom of such a large construction in this suburb.

- 1. As you know St Ives is not on the train line. Inadequate public transport is a problem. Along with already congested roads!!
- 2. The large number of units already built on Mona Vale Road and Memorial Road are considered an eyesore and not fully occupied.
- 3. The large number of units on the Pacific Highway stretching from Chatswood to Hornsby cater for people wishing to buy a unit and a lot are unsold. (See SMH article Saturday, 2 October).
- 4. St. Ives is a suburb of primarily housing for families, I do know of many people in this area wanting to downsize, BUT do know .... they want a villa or a townhouse, not a unit!!!!!!
- 5. Where is the extra infrastructure to cope with all these extra units and larger population?????? I am unaware of any extra roads planned, electricity, water or sewerage plans????
- 6. Meriton Builders own so much land in St Ives already WHY ... are there no other developers in this suburb, do they have a 'special arrangement' with the State Government??
- 7. Questionnaires have been sent out over the years and the overwhelming response has been that no one wants a bigger shopping centre than we already have, but ... the owners, who are they and their connection to all this over development?????? totally disregard our thoughts and wishes!! Yes, we would like the parking to be a little bigger, that's all!!! We are surrounded by Westfield shopping centres already.
