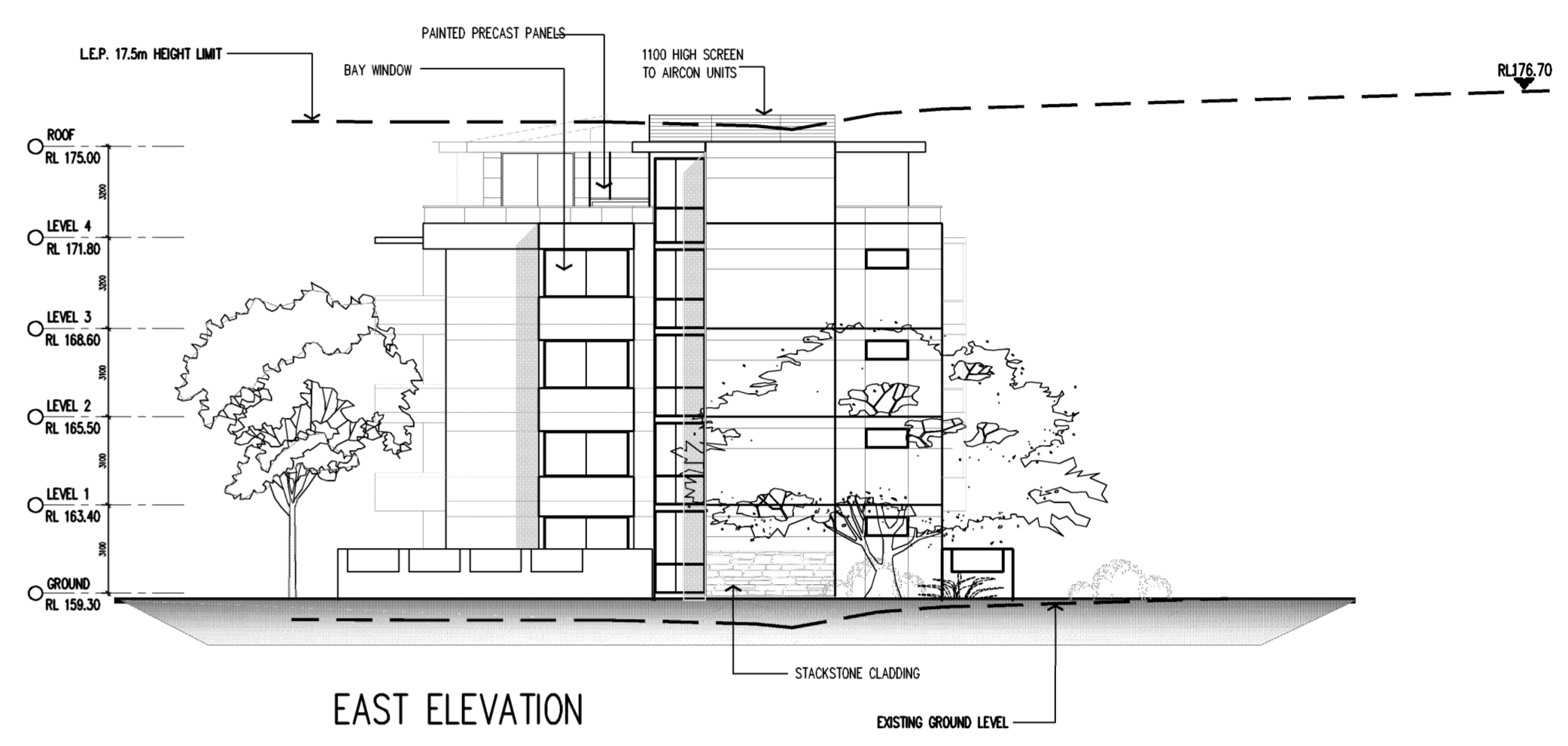
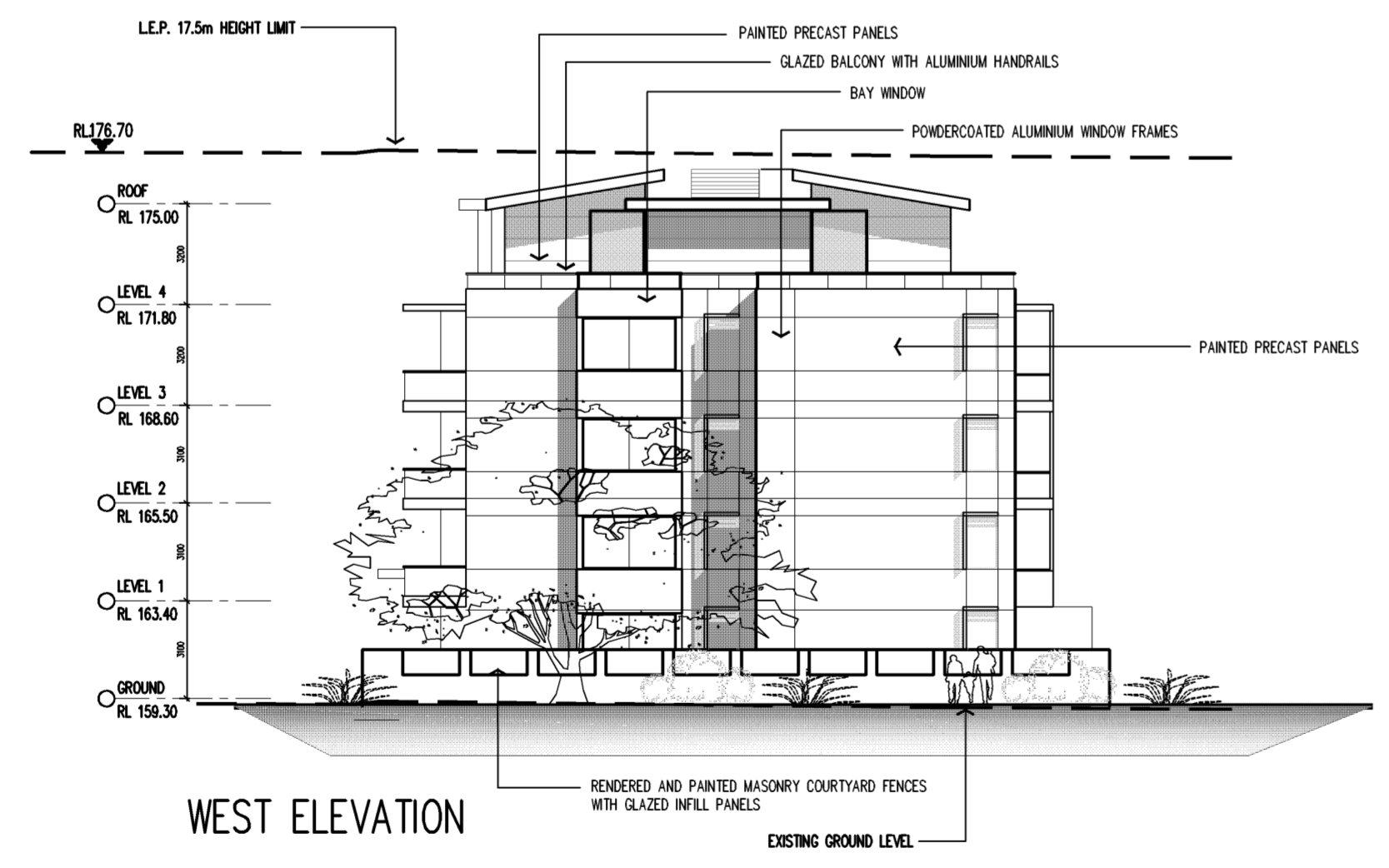


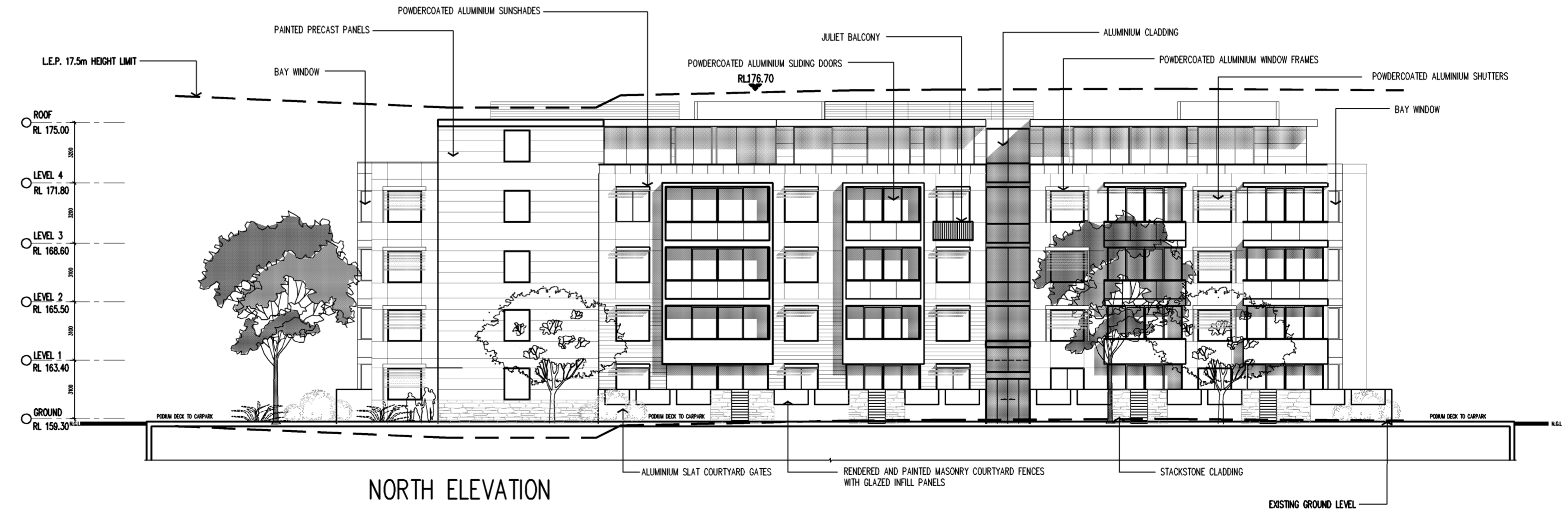
SOUTH ELEVATION
