We are most concerned that this proposal affects our area and we were not advised.

I understand that only a very few local residents and businesses were circulated the proposal.

I am not happy at all with this, what appears to be, major change in our local area. We already have days when the smell from the Kimbriki tip

is very bad and this new project with putrescible food waste will only make it worse.

It has been very poorly handled to say the least. A project which will have lasting negative impacts on the area should have had some community

input but this cannot have happened as so few people are aware of this project.

At this stage, from the little that I have seen and heard, there will be many more trucks and tonnes of additional waste being proposed to come into
