The amended concept plan that shows the removal of the internal road and introduction of the cul-de-sac area at the end of the proposed driveways is all that is required for the NSW Bushfire Services to access the site in the event of a bushfire, to comply with requirements of *Planning for Bushfire Protection 2006*. Provided the proposed development is constructed in accordance with the recommendations included in the NSW RFS Provision of key issues and assessment statement (that formed part of Condition F19 of the Project Approval MP10_0177, dated the 18 January 2011), it is my considered opinion that the development, including the revised road design, satisfies the Aims and Objectives of '*Planning for Bushfire Protection 2006*' and the requirements of '*Australian Standard AS3959, 2009 Construction of Buildings in Bushfire Prone Areas*'.
