In relation to future substations, and the existing electrical substation (S1514) fronting Smith Street, Ausgrid would like to remind you to ensure that due consideration is given to the compatibility of the proposed Stages of design with reference to segregation, construction and site selection as outlined in Ausgrid's Network Standards.

Stephen,

Thanks for your time yesterday to discuss the above project. A summary of our discussions were that Stages 1 and 2 could be serviced from the existing sub station and it was likely that Stages 3 and 4 may require a separate kiosk sub station each served from HV lines in Edward St for Stage 3 and Smith St for Stage 4. If necessary at a later stage, the existing sub station could be replaced by a kiosk sub station in the general location of the existing sub station. Please confirm that this summary is as discussed and agreed in the meeting.

As promised, attached are plans showing the proposed staging, an estimate of the power demand for Stage 2 and a rough estimate of the power demand for the entire development for your preliminary information.

Arup will confirm these demands in separate applications for Stages 1 and 2. Arup will also update you on the status of Stage 1 development in its application.
