Re: Advice on Modification Report – Maryvale Solar Farm MOD 1 - Battery Energy Storage System (SSD-8777-Mod-1).

Fire and Rescue NSW (FRNSW) acknowledge correspondence received on the 20th January 2022, requesting Advice on the Modification Report for Maryvale Solar Farm MOD 1 -Battery Energy Storage System (SSD-8777-Mod-1).

FRNSW have reviewed the Modification Report along with Appendix F Preliminary Hazards Analysis (PHA) and make the following comments:

FRNSW note recommendations made in the PHA that the applicant integrate the register of commitments (Appendix 1 of the PHA) into the design, installation, and maintenance of the Battery Energy Storage System (BESS).

FRNSW note that detailed design of the BESS is currently unavailable and the PHA recommends that "detailed firefighting response and the need for fire water containment should be assessed and reported (e.g. in the format of a Fire Safety Study)". Further, FRNSW note the remote location of the project site, and it is our experience that water supplies for firefighting are challenging to source and access in these locations.

Due to the unique challenges of combating a BESS fire in a remote location FRNSW make the following recommendations:

- 1. To ensure that the fire prevention, detection, protection and firefighting measures are appropriate to the specific fire hazards and adequate to meet the extent of potential fires, a comprehensive Fire Safety Study (FSS) is recommended to be undertaken.
- 2. That the FSS is developed in accordance with the requirements of Hazardous Industry Planning Advisory Paper No.2 (HIPAP No.2).

- 3. That the FSS is required to be developed to the satisfaction of the operational requirements of FRNSW. FRNSW recommend that the development of a FSS be a condition of consent.
- 4. That the development of the FSS considers the operational capability of local fire agencies and the need for the facility to achieve an adequate level of on-site fire and life safety independence.

Should a fire or hazardous material incident occur, it is important that first responders have ready access to information which enables effective hazard control measures to be quickly implemented. Without limiting the scope of the Emergency Response Plan (ERP), the following matters are recommended to be addressed:

- 5. That a comprehensive ERP is developed for the site.
- 6. That the ERP specifically addresses foreseeable on-site and off-site fire events and other emergency incidents, (e.g. fires involving the BESS or solar panels, bushfires in the immediate vicinity or potential hazardous material incidents).
- 7. That the ERP detail the appropriate risk control measures that would need to be implemented in order to safely mitigate potential risks to the health and safety of firefighters and other first responders (including electrical hazards). Such measures would include the level of personal protective clothing required to be worn, the minimum level of respiratory protection required, decontamination procedures, minimum evacuation zone distances and a safe method of shutting down and isolating the BESS (either in its entirety or partially, as determined by risk assessment).
- 8. Other risk control measures that may need to be implemented in a fire emergency due to any unique hazards specific to the site should also be included in the ERP.
- 9. That two copies of the ERP are stored in a prominent 'Emergency Information Cabinet' which is located in a position directly adjacent to the site's main entry point/s.
