Detailed advice to DPE Planning & Assessment regarding the Berrima Cement Works – SWDF Increase & Delivery Variation Modification 14 (DA401-11-2002-I-Mod 14) – Modification Report

1.0 Water Take

1.1 Recommendation – Prior to Determination

The proponent should:

• Confirm water demands and water licences required for construction and any additional operational requirements due to the modification. Where additional water licences are required, the ability to acquire these needs to be demonstrated.

1.2 Explanation

• Insufficient information has been provided to confirm the water requirements for construction, and if applicable ongoing maintenance of the proposed modification activities.

2.0 Works within Waterfront Land

2.1 Recommendation – Prior to Determination

The proponent should:

 Confirm works on waterfront land for the modification activities, particularly the mapped watercourse which is to be crossed by the proposed Berrima Entry Road. Works within waterfront land is to show due consideration to the Guidelines for Controlled Activities which can be found at: <u>https://www.industry.nsw.gov.au/water/licensing-trade/approvals/controlledactivities/guide</u>

2.2 Explanation

• The proposed Berrima Entry Road crosses a mapped first order watercourse, however the modification report states there are no works on waterfront land.

2.3 Recommendation – Post Determination

• Works within waterfront land need to be in accordance with the "Guidelines for Controlled Activities on Waterfront Land (NRAR 2018)".
